## REQUEST FOR INFORMATION: Statistics on poultry populations

Thank you for your request for information of 3rd July about Statistics on poultry populations. APHA have handled your request under the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

"In accordance with section 1 of the Freedom of Information Act 2000 and regulation 5 of the Environmental Information Regulations 2004, we request information in relation to poultry premises on and around European protected sites.

On this issue, we request provision of the following information at your earliest convenience:

- How many, if any, poultry premises, registered on the poultry register, operate on Special Protection Areas (SPA) or within a 500m boundary around SPAs in England?
- How many, if any, of these premises are registered for chicken, gamebirds and duck and geese and how many of each species are kept in these premises?
- How many, if any, of these premises operate outdoor husbandry systems either alone or in combination with indoor units (data broken down by bird species)?

Clarity was sought and responded to below:

"SPAs, Special Protection Areas under the Conservation of Habitats and Species Regulations 2017, are a type of European protected sites.

To simplify the request. Could APHA please provide all registrations of premises on he current registration system and the poultry register, in case these terms are not being used interchangeably, for all European protected areas including the 500m buffer zone around these areas, as per DEFRA's gamebird map.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Could you please break down the data in relation to different bird species and indicate which of these premises operate outdoor systems either alone or combined with indoor premises."

The information APHA hold is a current snapshot of the information passed to APHA at the point of registration, APHA do not hold historical statistical information. It is the responsibility of the livestock keeper to inform APHA of any changes.

Poultry species included are the ones defined by the Department for the Environment Food and Rural Affairs (DEFRA) being,

Chicken, Duck, Goose, Guinea Fowl, Ostrich, Partridge, Pheasant, Quail, Turkey and Rhea.

The available information you have requested can be found at Appendix 1. Any blank sections on the spreadsheet mean that the information is not held by APHA.
