REQUEST FOR INFORMATION: Poultry statistics - Scotland and Northern Ireland

Thank you for your request for information of 21st July about Poultry statistics - Scotland and Northern Ireland. APHA have handled your request under the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

"I am looking for information on poultry farms in Scotland and Northern Ireland that do not meet the threshold for Environmental Permitting Regulations (formerly IPPC), i.e., hold below 40,000 poultry birds. I understand that any farm holding more than 50 birds must be registered with the APHA. Under the Freedom of Information Act 2000, please can I have the following data for poultry units with fewer than 40,000 poultry, but more than 1,000 birds, including:

- * how many poultry farms (sub-permit threshold) there are in total in Scotland
- * how many poultry farms (sub-permit threshold of 40,000) there are in total in Northern Ireland
- * town/county of holding/farm month/year of registration
- * business activity- farmer, poultry company only (pet owner or hobbyist activity not required)
- * poultry numbers
- * species- chickens, pullets, turkeys, ducks etc
- * production details egg laying, reared for meat, breeding for meat, growing pullets up etc
- * husbandry system, i.e., indoor only floor, indoor only caged/mixed/outdoor only etc
- * farm management system intensive, extensive, free-range, organic

I require data for currently active poultry holdings and the number of active farms each year for the past 5 years (starting 2017) please."

The information APHA hold is a current snapshot of the information passed to APHA at the point of registration, APHA do not hold historical statistical information. It is the responsibility of the livestock keeper to inform APHA of any changes. APHA do not hold information for Northern Ireland this can be accessed via DAERA here:
