Improvements to FDM definitions and other language to aid clarity for the Regulated Community. Clarification on requirements for RPAS categories (RFC). Additional AMC for scenarios where FDR is fitted but routinely obtaining or exploiting flight data is unworkable. Added GM to remove the requirement for FDM Programmes to be implemented for Air Systems being operated within the Military Operated (Development) or Civilian Operated (Development) Defence Air Environment Operating Categories. This is currently the subject of existing Waivers within the RC. GM to clarify ability of ODH / AM(MF) to choose to argue for implementing an acceptable FDM that delivers the regulatory intent using alternate data sources if no FDR exists (RFC). Addition of GM to include further reference sources in addition to CAP739 Updates to footnote references.
