# SUMMARY MINUTES OF THE INTERIM DEVICES WORKING GROUP MEETING HELD ON TUESDAY 4<sup>TH</sup> JULY 2023

#### Papers for advice

#### Effect of darker skin pigmentation on the accuracy of pulse oximeters

The Group was presented with a summary of the MHRA's proposed risk mitigation strategy to address the risk of inaccuracy with pulse oximeters on different skin pigmentation.

The Group agreed with MHRA's proposed strategy which included proposals for communication and education to raise awareness about the limitations and appropriate use of pulse oximeters and particularly including the risk of inaccuracy with darker skin tone. Additionally, longer-term regulatory approaches were proposed to ensure the impact of skin tone on the accuracy of pulse oximeter is addressed during the conformity assessment process and during post market surveillance of these devices.

The MHRA will develop a communication package and dissemination plan and will bring this back to the Group for consideration and discussion.

#### Any other business

The Group were advised by the Chair that there will be a standing item going forward, dedicated to internal Agency device related updates.

The Group were presented with an update regarding a bed rail entrapment 'signal'.

The Group heard an update regarding revision of the current Managing Medical Devices guidance.

The Group were advised that the V60 ventilator national patient safety alert has now been published.
