You would like opportunities to speak with the Maritime and Coastguard Agency (MCA) regularly.	MCA representatives have joined the Regional Fisheries Group (RFG) team on port visits to answer questions directly.
Southeast fishers requested more opportunities for engagement with the RFG team.	We carried out RFG port visits to Newhaven and Eastbourne, Poole, Swanage and Lymington over September and October of this year.

### Fisheries Management Plans (FMPs)

On 01 October 2023 the consultation period for the frontrunner Fisheries Management Plans closed.

All the responses online and from engagement sessions will now be reviewed prior to the Fisheries Management Plans being published in December 2023.

Department for Food, Environment and Rural Affairs (Defra) is now preparing the next FMPs for English waters:

Cockles, queen scallop, North Sea and Channel sprat, Southern North Sea demersal non-quota species and Southern North Sea and Channel skates and rays.

#### **Seal depredation survey**

Dr. Claire Tanner from the University of Oxford (MCEM group) has been travelling around the UK coasts interviewing fishers for her research on the effects of seals on fishers'.

Their aim is to assess how interactions with seals affect UK fisheries (economically and via catch loss) and how these have changed over time, through an assessment of catch depredation and an interview.

The depredation assessment involves the fishing vessel/s photographing the partially-eaten fish and quantifying the amount of usable catch. The inperson interviews are now completed – but they are still interviewing fishers' over the phone if anyone is interested in participating.

### Grant funding opportunities

UK Seafood Fund - Infrastructure Round 3: Fleet Modernisation (Closing 13 December 24).

Up to £2 million in grant funding is available to modernize fishing vessels with replacement or modified engines.

This scheme is now open to any UK commercial licensed fishing vessel regardless of gear type or size, the grant caps have been raised, and the age of the current engine to be replaced has been amended (among other things).

This round is open for applications until midday on 13 December 24, or until all funding has been allocated. A link to the scheme web page is here:

## Inshore Vessel Monitoring System (I-VMS)

All fishers with under-12m vessels are urged to **act now** to purchase a type approved I-VMS device and claim up to  $\pounds$ 1,050 grant funding while it is available, or risk covering purchase and installation costs themselves.

#### The deadlines to apply for grant funding are:

- 6-12m vessels: 30 November 2023
- Under-6m vessels: 18 December 2023

<u>Start your grant claim</u> with proof of purchase. New legislation will come into force next year, expected in April 2024.

## Southern North Sea and English Channel skates and rays Fisheries Management Plan

The MMO are responsible for delivering this FMP, covering the following species in ICES Areas 4b, 4c, 7d and 7.e:

- Thornback ray
- Blonde ray
- Undulate ray
- Small-eyed ray
- Spotted ray
- Cuckoo ray
- Starry ray

Learning from previous FMPs, we are taking a new approach to identifying and troubleshooting issues within the fishery at a local scale, before engaging with stakeholders to understand whether our proposed solutions will support their needs.

A working group consisting of national representatives from commercial and recreational fishing sector, as well as NGOs, is being established to advise the team in the MMO.
