Thank you for your email of 9 October 2023 to the Ministry of Defence (MOD) requesting the following information:

"From 1st January 2020 to the current day, please provide information regarding all personnel from external, private sector organisations that have been seconded to work at your department, including:

The name of the organisation the secondee came from
The date and duration of the secondment at the department
A short description of each individual's role at the department
Amount paid in respect of the secondment by the department to the seconded worker's employer

If you are not able to provide all of the information listed above, please provide the information you are able to provide."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some of the information in scope of your request is held.

Personnel from external organisations who have been seconded during the period from 1 January 2020 to 30 September 2023 can be found on the table below:

Under Section 16 (Advice and Assistance), I can advise that during the period requested, the MOD has operated two Human Resources (HR) systems, the Human Resources Management System (HRMS) until end of January 2022 and MyHR from February 2022. Details are therefore based on a combination of results from both systems and include all individuals who worked for MOD at any point during the period, regardless of whether they joined before 1 January 2020 or have since terminated.

The Job Family grouping has been subject to review during the period covered by the FOI. Once on the transition from HRMS to MyHR in February 2022 and again in the summer of 2022. Where individuals terminated prior to MyHR release, the final HRMS value has been provided, while the latest MyHR category has been supplied for those who terminated after their record had migrated on to the new application.

Furthermore, the recording of the originating private company was not mandated in HRMS, and is not an option in MyHR.

As results have been taken from HRMS and MyHR, they only include departments that are managed on one of these platforms, this excludes RFA, Agencies and Arm's Length Bodies.

Although employment start dates are available for all secondees, projected end dates of employment are not always populated, so details for limited records could only be provided. This data would also be covered by the Data Protection Act 2018, Section 40(2) of the FOI Act.
