







Application for UK External Waters Licence to Access Regional Fisheries Management Organisation (RFMO) 2024

UK vessels intending to operate outside British Fishery Limits in Regional Fisheries Management Organisation (RFMO) regulated waters must have an external waters licence in addition to their base domestic licence. Use this form to apply to fish in RFMO waters to which the UK is a contracting party.

The UK Single Issuing Authority (UKSIA) will share valid applications and details therein with the relevant UK fisheries administrations. The UKSIA will only notify your vessel to the relevant RFMO and issue an external waters licence if all necessary information has been provided to the satisfaction of the UKSIA and your fisheries administration.

Your licence will be communicated by email and the applicable conditions are published on the <u>UKSIA website</u>. You must be in receipt of a valid licence and check that your vessel appears on the relevant RFMO list of notified and/or authorised vessels and UK external waters RFMO licence list prior to commencing activity in an RFMO's waters.
