

WCPG Declaration Form

The Woodland Creation Planning Grant (WCPG) provides support for the planning required to create woodlands in England which are compliant with the requirements and guidelines of the UK Forestry Standard. The Grant provides funding to help an effective woodland design process, covering the collection and analysis of key information and its application in the design and initial management of the woodland.

How to use this form

Please ensure you have downloaded the <u>latest version of this form</u> before completion.

To apply for the WCPG please complete this form, the Initial Application tabs of the WCPG Application and Plan (WCPG AAP) and a boundary map and send it to the Forestry Commission at the address stated below.

You may submit your application at any time. We will allocate the Grant on a first come first served basis, subject to your proposal passing basic eligibility checks and advice from the local Forestry Commission team on whether you have chosen a location that is potentially suitable for the creation of woodland. We may close the Grant depending on funding availability and demand so please check our website https://www.gov.uk/guidance/woodland-creation-planning-grant for news on any closure dates.

We are required to collect several personal details of the applicant, land agent, or landlord to be able to process your application. Further information on how we will use your information and your rights under the UK's data protection legislation can be found in Section 1 below.

How we process your application

Once we receive your application, we will make some basic checks to confirm your proposal is eligible. We may need to contact you to finalise some of the details. We aim to provide you with an answer within ten working days of receiving your application.

Your grant will be offered in two stages, with optional supplementary payments:

- Stage 1 (a Fixed Payment of £1,500) this is paid for a desk-based exercise to complete Stage 1 of the WCPG AAP identifying constraints and opportunities for the site and preparing at least one map (a Landscape Context Map). If the Forestry Commission decides there's potential for planting woodland on the proposed site then you'll be offered a Stage 2 agreement. You must not start work on the Stage 1 of the WCPG AAP until a signed grant agreement is in place with the Forestry Commission.
- Stage 2 (a Standard Payment of £150 per hectare up to a maximum of £30,500, minus the £1,500 paid at Stage 1) You will receive a Stage 2 payment for producing a woodland creation design plan by completing Stage 2 of the WCPG AAP. You will find a list of required maps and plans in the WCPG AAP. This includes: Site Appraisal Plan, a Design Concept Plan and Spatial Plan showing the final woodland creation design. Where planting is proposed on existing semi-natural habitat a Phase 2 habitat survey will also be required. We will pay the WCPG standard rate on the gross area in the final plan with payments capped at the net planted area plus up to 20% of the gross area (to account for designed open space and land left unplanted to be managed for environmental objectives). You will never be paid less than £1,500 for completion of Stage 1 and £500 for completion of Stage 2. You must not start work on Stage 2 of the WCPG AAP until a Stage 2 offer has been made by the Forestry Commission.
- **Supplementary Payments:** If a more detailed assessment is needed (such as a habitat survey, landscape and visual impact assessment, or an archaeological survey) then you can apply for a Supplementary Payment using the separate <u>Supplementary Payment application form</u>. We will pay 70% of the actual costs based on three quotes for these assessments. For peat, vegetation and bird surveys, a standard cost option is available based on 60% of the average cost for these assessments. The total amount of funding (including Stage 1 and 2 payments) is capped at £30,500 per project. Supplementary Payment offers are made subject to availability of funding and at the Forestry Commission's discretion.



Section 1 - Data protection and release of information

Please read the below statements and ensure you understand how the Forestry Commission will handle any information submitted as part of your WCPG application. As lead applicant, you are responsible for informing any third parties of how the Forestry Commission will handle information relevant to them.

Data Protection Act 2018

The Forestry Commission (FC) will use any information you provide, to support the administration of the scheme. Without your personal information, we will not be able to process your application. The FC or its appointed agents may also use it, in keeping with the safeguards of the Data Protection Act, in the following ways:

- For communication with other organisations including Defra, other government departments (and their agencies) and local authorities in the administration of the application and subsequent grant agreement.
- For producing operational information and statistics.
- To contact applicants or their agents in connection with occasional research aimed at improving the services that the FC provides.

Your personal information will be stored securely in the UK and will be kept for at least 7 years after the final payment of grant or after the last financial transaction. Your personal information will be shared with other Defra bodies for the purpose of administering and processing your application to the Fund.

You have a number of rights under the Data Protection Act 2018, which are listed on the Information Commissioner's website. You have the right to lodge a complaint with a supervisory authority, the Information Commissioners' Office, on their website, https://ico.org.uk/

The Forestry Commission is a data controller under the Data Protection Act 2018. You can read our Personal information charter online.

Release of information

The Forestry Commission is required to release information, which may include personal data and commercial information, to comply with the Environmental Information Regulations 2004 and the Freedom of Information Act 2000. This may include details such as name and address of the applicant, property, grant recipient, type of grant and grant value. However, the Forestry Commission will not permit any unwarranted breach of confidentiality nor will it act in contravention of its obligations under the Data Protection Act. The Forestry Commission may also publish additional information on its own website.



Section 2 - Lead Applicant Declarations

- 9. I am not in receipt of, have not received or applied for, nor do I intend to apply for, any other government funding that would duplicate or conflict with this Application.
- 10.To the best of my knowledge and belief the information given throughout the Application process is accurate and complete, and I understand that I am liable for any false declaration.
- 11.I will ensure the necessary consents and land access agreements for planting are in place prior to undertaking works.
- 12.I am aware of the need to seek other legal permissions in relation to this site and will ensure that these permissions, wherever necessary, are in place prior to carrying out my project.



13. I understand that I am applying for the WCPG scheme, and that the Forestry Commission may give an Environmental Impact Assessment (EIA) Opinion under its own motion.
