EXPORT OF CATS AND DOGS TO MACAU FROM UNITED KINGDOM

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OVs) and exporters. The NFG should have been issued to you together with export certificate 5469EHC. The NFG should not be read as a standalone document but in conjunction with certificate 5469EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. Scope

5469EHC may be used to accompany cats and dogs to Macau. Macau currently imposes age restrictions on animals to be imported (see paragraph 4 below). In case of doubt, you should consult APHA Centre for International Trade, Carlisle.

2. Certification by an Official Veterinarian (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

• if the exported commodity is cattle, pigs, sheep, goats or camelids;

• if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: Provision of certified copies

aPVPs certifying DECOL produced Export Health Certificates must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the department, where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. Import Permit

A valid import permit is required. Exporters are advised to apply in advance to the Department of Environment and Public Sanition, Islands Municipal Council of Macau.

4. Restrictions on the age of cats and dogs

Cats and dogs under 4 months old must not be imported into Macau.

5. <u>Identification</u>

Paragraph I refers. The identification schedule should be fully completed. The cats and dogs should be identified either by tattoo or microchip number or by a full description including coat colour and type, markings, weight, breed and sex. The age of the animal must be declared.

6. Clinical examination

Paragraph IV (e) refers. The clinical examination should be carried out on the date of signature of the certificate.

7. Rabies vaccination

Paragraph IV(c) refers. The animal should be vaccinated against rabies using a licensed product, in accordance with the manufacturer's instructions, not less than 30 days and not more than one year prior to export. The date of vaccination, name and manufacturer of vaccine should be recorded on the certificate.

8. <u>Transportation</u>

The animal must be transported by the most direct route from United Kingdom to Macau.

9. Welfare

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.

Information about welfare during transport in Great Britain and the
