## EXPORT OF DOGS AND CATS FROM THE UNITED KINGDOM TO JORDAN

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

### IMPORTANT

These notes provide guidance to Official Veterinarians (OVs) and exporters. The NFG should have been issued to you together with export certificate 3907EHC. The NFG should not be read as a standalone document but in conjunction with certificate 3907EHC. The information sets out, to the best of the Department's knowledge, the import requirements for Jordan as at August 1996.

We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

#### 1. SCOPE OF THE CERTIFICATE

Export health certificate 3907EHC may be used for the export of dogs and cats from the United Kingdom to Jordan.

## 2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

#### Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

• if the exported commodity is cattle, pigs, sheep, goats or camelids; • if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

### DAERA Export Health Certificates: Provision of certified copies

aPVPs certifying DECOL produced Export Health Certificates must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the department, where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

### 3. **EXAMINATION**

The examination at Paragraph IV. (a) should be carried out not more than 48 hours prior to the date of export.

#### 4. RABIES VACCINATION

Paragraph IV. b) refers. The Jordanian veterinary authorities require vaccination not less than 30 days and not more than 12 months prior to export. A rabies vaccination certificate must be completed by the veterinary surgeon who administers the vaccine. The use of rabies vaccine is not generally permitted in the United Kingdom but arrangements have been made for it to be made available for animals intended for export.

The vaccination certificate should be attached to the Export Health Certificate.

## 5. TREATMENT

Paragraph IV. c) refers. Within 14 days of export, the animals must be treated against tapeworm using an approved product according to the manufacturer's instructions.

## 6. RESIDENCY IN THE UNITED KINGDOM

Paragraph IV. d) refers. We understand that the veterinary authorities in Jordan require animals to have been resident in the United Kingdom for six months prior to the export, or since birth. Exporters must provide the OFFICIAL VETERINARIAN with a written declaration to this effect. The declaration must also state that it is the owner's intention to export the animal from the United Kingdom.

# 7. **DISEASE CLEARANCE**

OFFICIAL VETERINARIANS may certify paragraph IV. e) on behalf of the Department provided written authority to do so has been obtained from the APHA Centre for International Trade, Carlisle or the issuing office of DAERA in Northern Ireland on form 618NDC.

## 8. VACCINATIONS

Before signing the export health certificate, the OFFICIAL VETERINARIAN must be satisfied that the necessary vaccinations have been carried out. If vaccinations are carried out by another veterinary surgeon, the owner/exporter should provide evidence in the form of certificates. Vaccination certificates must be attached to the export health certificate.

## 9. WELFARE DURING TRAVEL

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions

required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.
