## Purpose of the grant

On 15 December 2023, the Department for Education issued the 2023 revision of statutory guidance, Working Together to Safeguard Children (Working Together) and the new statutory guidance, the Children's Social Care National Framework (National Framework).

Working Together and the National Framework set direction for the system, and describe the practice that is needed for children, young people and families to thrive. Effective working within local areas' multi-agency safeguarding arrangements is at the heart of both documents is at the heart of both documents.

The revised Working Together seeks to clarify the roles and responsibilities of safeguarding partners, setting out clearly their roles as strategic leaders who are jointly accountable for ensuring children and families in their area are supported by strong, well-resourced multi-agency safeguarding arrangements. The new National Framework sets out the purpose of children's social care, principles for practice and the outcomes that should be achieved. It includes expectations for practice for local authority senior leaders, practice supervisors and practitioners.

All local areas are expected to consider and begin to apply guidance when guidance is published. In Stable Homes, Built on Love we stated local authorities will have an implementation period of one year following the publication of the National Framework to consider the level of change needed to meet its expectations and outcomes.

We are asking every local area to review current practice, identify what needs to change and drive forward improvement, considering Working Together and the National Framework. Statutory guidance must be embedded in local systems if it is to have an impact.

We are providing all **137 multi-agency safeguarding arrangements** with grant funding to support areas to transform local systems, and deliver the reforms set out in Chapter 2 of Working Together and embed the practice described in the National Framework. In addition, we have published advice, <a href="Improving practice with children">Improving practice with children</a>, young people and families, which offers information and support on how local areas can start to plan for changes to their local approach to practice.

Each multi-agency safeguarding arrangement will receive a payment **in January 2024** to support them to move towards their new ways of working. Annex A provides details of payments being made to all local authorities. Where there is more than one local authority within the MASA structure, we have engaged in consultations and will allocate the money to one specific LA, this is outlined in Annex A. DfE expects this one-off payment be used in the financial year 2023/24.

Funding will be allocated via the lead local authority within the multi-agency safeguarding arrangement as the preferred mechanism through which the Department for Education provides grants. Funding is to be used for the purposes of strengthening the multi-agency safeguarding arrangements and therefore should benefit, and be agreed, by all three statutory safeguarding partners.

Each local authority/multi-agency safeguarding arrangement will have a named DfE Grant Manager who will be their route to raise questions or share concerns. All multi-agency safeguarding arrangements will be expected to submit an 'Annex G' form in March 2024, setting out funding has been used, alongside the submission of the yearly report in September 2024 and republication of published arrangements in December 2024 as set out in Working Together quidance.

The Secretary of State for Education ("the Secretary of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

## **Citation**

1) This determination may be cited as the Strengthening Multi-Agency Leadership for CSC Reform: Supporting the Implementation of Working Together and National Framework Determination 2023 [No31/6929].

# Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

#### **Determination**

3) The Secretary of State for Education determines the authorities to which grant is to be paid and the amount of grant to be paid; these are set out in Annex A.

## **Payment of Grant**

4) The Grant will be paid in one instalment in January 2024.

### **Treasury consent**

5) Before making this determination in relation to local authorities in England, the Minister of State obtained the consent of the Treasury.

- 5) The Grant Recipient shall at all times during and following the end of the Funding Period:
- 5.1 comply with requirements of the Branding Manual in relation to the Funded Activities; and
- 5.2 cease use of the Funded by UK Government logo on demand if directed to do so by the Authority.
