HS2 Ltd noted that Warwickshire County Council had provided updates via email that had been incorporated into the table. South: LB Camden gave verbal updates via conference call in relation to: Vent shafts: considered to be locally specific issue and not relevant to route wide lead authority process. Planning: LB Camden to progress route wide discussion on planning matters. HS2 Ltd confirmed that position on Sch. 16 petitioning points had been shared with Planning Forum in Sept. 2014. HS2 Ltd confirmed that they would meet with LB Camden as load authority and planning matters.

5.1	Parliamentary Process Update	
	 DfT provided an update on the parliamentary process, and presented slides on the following: Changes to Select Committee members following the general election and the intention for Select Committee to reconvene on 8th June whist replacements are being found; Recess dates, the next being the summer recess (21st July-7th Sept); HS2 Select Committee dates and appearances – it was noted that Select Committee had previously sat for two weeks during the conference recess; and Additional provisions (AP2 and AP Euston) and the intention to submit a Supplementary Environmental Statement (SES) to the HS2 Environmental Statement with AP2 in mid – July 2015. 	

	<i>South:</i> South Bucks DC asked if all of AP2 will be published at the same time. DfT / HS2 Ltd clarified that content of AP2 will be consulted on collectively and anything not included will be incorporated into subsequent APs.	
	<i>South:</i> LB Camden asked what the SES will include. DfT / HS2 Ltd explained that the SES relates solely to the previously deposited HS2 ES and will mainly include new and updated survey information. LB Camden and Warwickshire CC asked how consultation will work. DfT reiterated that the consultation process will run alongside AP2 consultation in terms of timescales.	
	<i>North:</i> Northamptonshire CC asked whether, if new effects arise in the SES (e.g. noise), can the council petition on these matters? HS2 Ltd highlighted that the SES will clearly report effects (if there is a change) and that authorities will be able to petition on the SES.
