Parent Title	ABN25532	The Title from which a part or parts are being transferred or removed via an application for registration of each part
Consideration	£145,000, £0	The monetary amount that is paid for a property transaction Please note that non-monetary considerations such as Love, Favour and Affection, Implementation of Will and Certain Good and Onerous Causes are all denoted as £0.
Value	£23,000	The amount stipulated as the value of a transaction when the price paid or consideration is not the true market value (please note that value provided may only relate to a share of the property).
Date of Entry	18/02/15	The whole rights of ownership pass or are deemed to pass as at the date of entry.
Application Date	18/02/15	The date the application is created on the RoS land registration system.

¹ FR – First Registration: the term given to the registration of a previously unregistered (in the Land Register) interest in land that requires the Keeper to make up a Title Sheet for that interest.

TP – Transfer of Part: the term given to the registration of a Dealing with part of a registered interest in land that requires the Keeper to make up a separate Title Sheet for that interest.

DW - Dealing with Whole. Once subjects are recorded in the Land Register, any subsequent transactions affecting the whole subjects are known as a DW.

² FA - First Attached - a registration in the Land Register of a previously unregistered interest in land which is being added to an existing Title.

TA - Transfer Attached - a Dealing with only a part of a registered interest which creates a new interest in land which is being added to an existing title.

³ Other is a term used for transactions that cannot be classed in any of the other five categories, for example a garage, car park, substation, fishing rights etc.
