Sea service must be evidenced by Discharge Book entries/Certificates of Discharge **and** testimonials detailing the cargoes carried during your periods of service. The testimonial must be signed by the Master and display the ship's stamp. You must complete sea service on the type tanker relevant to the endorsement you are applying for. Details of the requirements are stated in checklists 4B and 4C. Sea service for each endorsement must amount to 3 months completed within the last 5 years.

The training, together with the sea service must have been completed within the last 5 years.

Who needs a Tanker Endorsement?

If you are an Officer or Rating assigned specific duties or responsibilities related to cargo or cargo equipment on tankers you must complete STCW basic training for tanker operations before taking up such duties. **This can be demonstrated by obtaining a**Certificate of Proficiency issued by an approved STCW training provider.

If you are a Master, Chief Engineer, OOW*, Chief Mate, Second Engineer or any person with immediate responsibility for loading, discharging, care in transit, handling of cargo, tank cleaning or other cargo-related operations on tankers you must obtain an STCW Advanced Training endorsement before taking up such duties.

If you are an Engineer Officer of the Watch serving on tankers you are required to either have your Certificate of Competency endorsed or have a Certificate of Proficiency issued by the Administration for basic tanker training specific to the type of tanker on which you are serving. Until 31 December 2016 this was able to be a Certificate of Proficiency from an approved STCW training provider. After that date you must apply for Tanker Endorsement to be added to your CoC.

If you are a Rating (typically Pumpman and Bosun) with immediate responsibility for a cargo operation or equipment (e.g. tank stripping/cleaning) you are required to hold the Advanced Tanker training Certificate of Proficiency. **You can obtain a Certificate of Proficiency from an approved STCW training provider.**

*It is unlikely that a Deck Officer serving on a tanker will not have duties requiring the completion of the advanced tanker training. If you do not obtain an Advanced Tanker Endorsement Port or Flag State Control Officers may challenge this.

1 PERSONAL DETAILS

The information you provide is primarily used for issuing your UK Certificate of Competency (CoC)/ Flag State Endorsement (Certificate of Equivalent Competency) (FSE) but may also be used for other related purposes, and shared with other statutory bodies/organisations to enable them to fulfil their statutory obligations.

We will not disclose any financial details you provide to us. Once your payment has been processed all financial details are securely destroyed.

4 SEA SERVICE

If you are seeking to have your CoC endorsed with basic training for tanker cargo operations sea service may be demonstrated by Discharge Book entries only.

If you are seeking to have your CoC endorsed or be issued with advanced training for tanker cargo operations, sea service must be demonstrated by Discharge Book entries **and** a testimonial stating the cargoes carried during your period of service. A pro forma for the Sea Service Testimonial can be found in Annex A (page 11) of <u>MSN 1866 Amendment 1</u>. Acceptable testimonials must have the ship's stamp and be signed and dated by the Master **OR** other responsible company representative

5 CHECKLISTS

Certificates of Proficiency (CoP) - For Ratings and Non UK CoC holders.

If you are a British Rating or a UK Flag State Endorsement / Certificate of Equivalent Competency holder, and meet all the requirements in the relevant checklists 4B and 4C above, you may apply to the MCA to be issued with the appropriate CoP at the advanced level. This CoP will be accepted on UK-flagged ships and will be valid for a period of five years. **Your training must be MCA approved.**

If you are a Master or Officer and you are intending to serve on ships operating under a non-UK flag you will need to apply to the relevant administration for the endorsement.

If your CoC was issued by an Administration other than the UK, then there is no guarantee that this Administration will accept a UK issued CoP for the purpose of entering a tanker endorsement in your CoC.

To obtain a CoP You must include 1 passport size photograph. Your photograph must be passport approved, taken full face without a hat and measuring a maximum of 50mm x 40mm, and be in colour. The back of one photograph must include your name in BLOCK LETTERS and the signature of a Doctor, Bank Officer, Established Civil Servant, School Teacher or an authorised official within your shipping company. They should also write on the back of the photograph "I certify that this is a true likeness of Mr/Mrs/Miss/Ms/Dr etc......." A member of your family is **NOT** allowed to counter sign your photograph. The back of the other photograph must include your name in BLOCK LETTERS and your date of birth.

6 DECLARATION

Please read the declaration. Once you are sure that the information you have given is, to the best of your knowledge, true and complete, and that the documents submitted are genuine, given and signed by the persons whose names appear on them, you should sign the declaration with your usual signature, including the date. Please ensure your signature is inside the box as this will be transferred to your CoC.
