EXPORT OF DOGS AND CATS FROM GREAT BRITAIN TO BANGLADESH

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The Notes for Guidance (NFG) should have been issued to you together with export certificate 4134EHC. The NFG should not be read as a standalone document but in conjunction with certificate 4134EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. SUMMARY OF REQUIREMENTS

- Import permit ("No Objection Certificate") from the Veterinary Authorities of Bangladesh.
- Commercial consignments of cats and dogs are prohibited.
- Export health certificate issued by DEFRA.
- Animals must be examined by the OFFICIAL VETERINARIAN, not more than 48 hours prior to export;
- All cats and dogs are advised to be vaccinated against rabies not less than 90 days and not more than 12 months prior to export.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government or Welsh Government, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

• if the exported commodity is cattle, pigs, sheep, goats or camelids;

• if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and

supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

3. IMPORT PERMIT

Exporters should contact the Veterinary Authorities in Bangladesh in order to obtain a "No Objections Certificate." The address of the Bangladesh Veterinary Authorities is as follows:

4. RABIES VACCINATION

Paragraph III b) refers. Vaccination is advised, however the import permit should be consulted over the necessity. The alternative of non vaccination may be used if the OFFICIAL VETERINARIAN has seen an import permit which does not require rabies vaccine.

Rabies vaccination should be given at least 90 days and not more than 12 months prior to export. A rabies vaccination certificate should be completed by a veterinary surgeon who vaccinates the animals.

5. TRAVELLING THROUGH OTHER COUNTRIES

It is the responsibility of the exporter/agent to apply to the relevant authorities of any transit countries through which the animal(s) will travel for permission to transport the animals through these countries. Additional health certificate(s) may be necessary for these transit countries.

6. WELFARE DURING TRAVEL

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.
