Textual data - Addresses	Addresses have been populated for all charges.	Before: Some charges would only have an address referenced in the description of the charge.  After: All charges have addresses or a geographic description of the affected land.
Textual data – Missing/Invalid dates	The correct registration dates have been populated for all charges.	Before: Some charges would have a missing or invalid registration date.  After: All charges have the correct registration date populated.
Textual data – Personally Identifiable Data	Where personally identifiable data was found in the supplementary information, this details has now been removed.	Before: Some charges would have the telephone or perhaps email address of a customer  After: All charges have the correct information displayed whilst adhering to GDPR protocols.
