EXPORT OF CANNED/RETORTED GOODS FOR HUMAN CONSUMPTION CONTAINING 5% OR MORE ANIMAL PRODUCT (EGG/DAIRY) TO AUSTRALIA

NOTES FOR THE GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

Associated Documents: 7355EHC

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The NFG should have been issued to you together with export certificate 7355EHC. The NFG should not be read as a standalone document but in conjunction with certificate 7355EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. SCOPE OF THE CERTIFICATE

Export health certificate **7355EHC** may be used for the export of canned or retorted products containing 5% or more animal-derived ingredients (*egg, dairy & gelatin/collagen derived from hides & skins*) for human consumption to Australia.

Other than those specified above, no ovine, caprine or bovine-derived material is eligible for export with this certificate. IV. i & ii of 7355EHC refer.

The exporter must obtain an import permit from the Australian Department of Agriculture and Water Resources (DAWR) for their product, **or** official written confirmation from DAWR that the product to be exported does not require an import permit.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

• if the exported commodity is cattle, pigs, sheep, goats or camelids;

• if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other

EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: Provision of certified copies

aPVPs certifying DECOL produced Export Health Certificates must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the department, where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. HEALTH INFORMATION

Paragraphs IV i. and ii. refer:

• The OV must be satisfied that the material mentioned is not included in the product, either from his/her own knowledge of the product or from supplementary evidence, physical inspection and by examination of relevant documentation or other records including commercial documentation, veterinary statements, and valid declarations.

Paragraph IV. iii. 1.

• This may be certified on the basis of the OV's evidence resulting from the OV's familiarity with the processing, arrangements in place at the establishment, supported as necessary by physical inspection and by examination of relevant laboratory analysis/ data/ documentation or other records, and/or valid declarations.

Paragraph IV. iii. 2. (2.1 & 2.2)

The OV may certify this paragraph on the basis of physical inspection of the products to be exported, and by visual examination of the packaging to confirm compliance with current food hygiene legislation and the presence of a valid health mark on the product.

4. DISCLAIMER

This certificate is provided on the basis of information available at the time, and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country.
