Thank you for your correspondence of 5 October 2023 requesting the following information:

"I would like to make a FOI request with respect to Service Families Accommodation and the demographics of the user community.

Request 1: How many quarters of each type and grade are in the Defence Estate?

By family size (number of entitles dependent children), how many Service Families are there, how many of those families are entitled to Service Families

Accommodation?

How many Type 1 and 2 quarters are not tied to an appointment?"

Defence Infrastructure Organisation (DIO) provided you with a reply on 25 October 2023 under the reference FOI2023/11975 and on 30 October 2023, you asked for the following information:

"Please could you provide some clarity on my second question:

Q2. By family size (number of entitles dependent children), how many Service Families are there, how many of those families are entitled to Service Families Accommodation?

You have answered:

A2. As of 1 October 2023, there are 38,506 Service Families living in Service Family Accommodation (SFA). Due to General Data Protection Regulations (GDPR), we do not break down this data to determine the number of Service Families living in SFA by family size/number of entitled dependent children.

Please could you confirm who the 'we' refers to in this answer. Surely Defence is aware how many SP are married and how many children they have. This should be routine information held on any HR system especially in an organisation that requires

this information to be known to confirm entitlements and pay allowances such as LOA.

In addition to Q2 may I amend the wording to include rank.

Amended Q2: By Rank, then family size (number of entitles dependent children), how many Service Families are there?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that some of the information in scope of your request is held.

Firstly, I should explain that as information in scope of your request is held on the Joint Personnel Administration (JPA) System, which is administered by Defence Business Services, your request has been passed to our office to reply. However, we are only able to supply the NATO rank of the person holding the Service Family Accommodation (SFA). Due to General Data Protection Regulations (GDPR), the MOD does not break down this data to determine the number of service families living in SFA by family size/number of entitled dependent children.

Please find at Annex A a list of current active personnel in the Royal Navy, Army and RAF that have an occupied SFA recorded on JPA by NATO rank, as of 17 November 2023.

Under Section 16 (Advice and Assistance) it may be helpful if I explain that the figure of 38,506 provided was sourced from the DIO accommodation team from their database. The figures provided in Annex A have been taken from JPA and there is a slight difference in the total (36,698). Furthermore, in answer to "Please could you confirm who the 'we' refers to in this answer", I can confirm that 'we' refers to the DIO.
