# Review of an Environmental Permit for an Installation subject to Chapter II of the Industrial Emissions Directive under the Environmental Permitting (England & Wales) Regulations 2016

# Decision document recording our decision-making process following review of a permit

#### What this document is about

Article 21(3) of the Industrial Emissions Directive (IED) requires the Environment Agency to review conditions in permits that it has issued and to ensure that the permit delivers compliance with relevant standards, within four years of the publication of updated decisions on best available techniques (BAT) conclusions.

We have reviewed the permit for this installation against the revised BAT Conclusions for waste incineration published on 3<sup>rd</sup> December 2019. This is our decision document, which explains the reasoning for the consolidated variation notice that we are issuing. This review has been undertaken with reference to the decision made by the European Commission establishing best available techniques (BAT) conclusions ('BAT conclusions') for incineration as detailed in document reference C(2019) 7987. It is our record of our decision-making process and shows how we have taken into account all relevant factors in reaching our position. It also provides a justification for the inclusion of any specific conditions in the permit that are in addition to those included in our generic permit template.

It explains how we will ensure that the installation complies with the BAT conclusions by 3<sup>rd</sup> December 2023. It is our record of our decision-making process and shows how we have taken into account all relevant factors in reaching our position. It also provides a justification for the inclusion of any specific conditions in the permit that are in addition to those included in our generic permit template.

As well as ensuring that the Installation complies with the BAT conclusions the consolidated variation notice takes into account and brings together in a single document all previous variations that relate to the original permit issued. It also modernises the entire permit to reflect the conditions contained in our current generic permit template.

The introduction of new template conditions makes the Permit consistent with our current general approach and philosophy and with other permits issued to installations in this sector. Although the wording of some conditions has changed, while others have been removed because of the new regulatory approach, it does not reduce the level of environmental protection achieved by the permit in any way. In this document we therefore address mainly our determination of substantive issues relating to the new BAT Conclusions.

Throughout this document we will use a number of expressions. These are as referred to in the glossary.

We try to explain our decision as accurately, comprehensively and plainly as possible. We would welcome any feedback as to how we might improve our decision documents in future. The use of technical terms and acronyms are inevitable in a document of this nature: we provide a glossary of acronyms near the front of the document, for ease of reference.

#### 2 Our decision

We have decided to issue the consolidated variation notice to the operator. This will allow it to continue to operate the Installation, subject to the conditions in the consolidated variation notice.

We consider that, in reaching that decision, we have taken into account all relevant considerations and legal requirements and that the varied permit will ensure that a high level of protection is provided for the environment and human health.

The consolidated variation notice contains many conditions taken from our standard Environmental Permit template including the relevant Annexes. We developed these conditions in consultation with industry, having regard to the legal requirements of the Environmental Permitting Regulations and other relevant legislation. This document does not therefore include an explanation for these standard conditions. Where they are included in the Notice, we consider that those conditions are appropriate.

#### 3 How we reached our decision

# 3.1 Requesting information to demonstrate compliance with BAT Conclusions for incineration Plant

We issued a Notice under Regulation 61(1) of the Environmental Permitting (England and Wales) Regulations 2016 (a Regulation 61 Notice) on 10/12/21 requiring the Operator to provide information to demonstrate how the operation of their installation currently meets, or will subsequently meet, the revised standards described in the incineration BAT Conclusions document. The Notice also required that where the revised standards are not currently met, the operator should provide information that:

- Describes the techniques that will be implemented before 3<sup>rd</sup> December 2023, which will then ensure that operations meet the revised standard, or
- Justifies why standards will not be met by 3<sup>rd</sup> December 2023, and confirmation of the date when the operation of those processes will cease within the installation or an explanation of why the revised BAT standard is not applicable to those processes, or
- Justifies why an alternative technique will achieve the same level of environmental protection equivalent to the revised standard described in the BAT Conclusions.

Where the Operator proposed that they were not intending to meet a BAT standard that also included a BAT Associated Emission Level (BAT AEL) described in the BAT Conclusions Document, the Regulation 61 Notice requested that the Operator make a formal request for derogation from compliance with that AEL (as provisioned by Article 15(4) of IED). In this

circumstance, the Notice identified that any such request for derogation must be supported and justified by sufficient technical and commercial information that would enable us to determine acceptability of the derogation request.

The Regulation 61 Notice response from the Operator was received on 11/04/22.

3.2 Review of our own information in respect to the capability of the installation to meet revised standards included in the BAT Conclusions document

Based on our records and previous regulatory activities with the facility we have no reason to consider that the operator will not be able to comply with the conditions that we include in the permit.

3.3 Requesting information to demonstrate compliance with Appropriate Measures for Healthcare Waste:

We issued a Notice under Regulation 61(1) of the Environmental Permitting (England and Wales) Regulations 2016 (a Regulation 61 Notice) on 10/12/2021 requiring the Operator to provide information to demonstrate how the operation of their installation currently meets, or will subsequently meet, the Appropriate Measures for Healthcare Waste document. The Notice also required that where the revised standards are not currently met, the operator should provide information that:

- Describes the techniques that will be implemented before 3<sup>rd</sup> December 2023, which will then ensure that operations meet the revised standard, or
- Justifies why standards will not be met by 3<sup>rd</sup> December 2023, and confirmation of the date when the operation of those processes will cease within the installation or an explanation of why the revised standard is not applicable to those processes, or
- Justifies why an alternative technique will achieve the same level of environmental protection equivalent to the revised standard described in the Appropriate Measures for Healthcare Waste.

The response from the operator was received on 11/04/2022.

3.4 Review of our own information in respect to the capability of the installation to meet revised standards included in the Appropriate Measures for Healthcare Waste document.

Based on our records and previous regulatory activities with the facility we have no reason to consider that the operator will not be able to comply with the conditions that we include in the permit.

#### 4 The legal framework

The consolidated variation notice will be issued under Regulation 20 of the EPR. The Environmental Permitting regime is a legal vehicle which delivers most of the relevant legal requirements for activities falling within its scope. In particular, the regulated facility is:

- an installation as described by the IED;
- subject to aspects of other relevant legislation which also have to be addressed.

We consider that the consolidated variation notice will ensure that the operation of the Installation complies with all relevant legal requirements and that a high level of protection will be delivered for the environment and human health.

We explain how we have addressed specific statutory requirements more fully in the rest of this document.

#### 5 The key issues

The key issues arising during this permit review are:

- Ensuring the Installation complies with the BAT conclusions.
- Setting emission limits (including BAT AELs) for emissions to air,
- The energy efficiency levels associated with the Best Available Techniques (BAT-AEELs)

#### 5.1 Ensuring the Installation complies with the BAT conclusions

We have reviewed the operator's response to the regulation 61 notice and we are satisfied that the Installation will meet the requirements of the BAT conclusions by 3<sup>rd</sup> December 2023. Further detail on our assessment is in annex 1 of this decision document.

Based on our records and previous regulatory activities with the Installation we have no reason to consider that the operator will not be able to comply with the conditions that we have included in the permit.

#### 5.2 Emissions to air and the emission limits applied to the plant

The consolidated permit includes new emission limits for emissions to air. These limits ensure that the installation will comply with the relevant BAT-AELs, as specified in the BAT conclusions, and the relevant limits from IED Annex VI.

A number of general principles were applied during the permit review. These included:

- The upper value of the BAT AELs ranges specified were used unless use of the tighter limit was justified.
- The principle of no backsliding where if existing limits in the permit were already tighter than those specified in the BREF, the existing permit limits were retained.
- Where a limit was specified in both IED Annex VI and the BAT Conclusions for a particular reference period, the tighter limit was applied and in the majority of cases this was from the BAT Conclusions.

We have set the emissions limit values at the top end of the BAT-AEL range in line with section 4.35 of Defra's Industrial emissions Directive EPR Guidance on Part A installations which states: Where the BAT AELs are expressed as a range, the ELV should be set on the basis of the top of the relevant BAT-AEL

SRCL Limited Oldham Clinical Waste Incinerator Permit Review DD range – that is to say, at the highest associated emission level - unless the installation is demonstrably capable of compliance with a substantially lower ELV, based on the BAT proposed by the operator, or exceptional environmental considerations compel a tighter ELV.

We are satisfied that environmental considerations do not require tighter ELVs to be set, and the operator has not proposed any lower ELVs, and so we have set the ELVs at the top end of the BAT-AEL ranges.

We have set IC1 which requires the operator to assess options to reduce NO<sub>x</sub> emissions below the top of the BAT AEL range.

#### 5.3 Energy efficiency

The BAT conclusions specify an energy efficiency level associated with the best available techniques (BAT-AEEL). The BAT AEEL is based on gross electrical efficiency, gross energy efficiency or boiler efficiency depending on the type of plant.

The relevant BAT AEEL for this installation is boiler efficiency.

The operator stated that the boiler efficiency has not yet been calculated. We have set improvement condition IC4 that requires the operator to calculate the efficiency and assess opportunities to improve energy efficiency in the event that boiler efficiency is below the BAT AEEL range.

#### 5.4 Monitoring

The monitoring requirements for mercury and dioxins/furans are dependent on whether the waste has low and stable mercury content and whether emissions of dioxins are stable respectively. Improvement conditions IC2 and IC3 require the operator to submit information to enable us to require the correct monitoring.

### 6 Issues not directly relating to the BAT conclusions

#### 6.1 Healthcare waste: appropriate measures for permitted facilities

The operator currently complies with all the waste pre-acceptance, acceptance and tracking appropriate measures given in the Healthcare waste: appropriate measures for permitted facilities guidance except the operator proposed alternative measures and we are satisfied that those measures provide an equivalent level of environmental protection.

The following alternative measures were agreed for waste acceptance appropriate measures 21 & 22, and waste tracking appropriate measure 6:

- Waste producers must label or tag each primary package to ensure that it can be traced to source. This is already a best practice requirement that is checked during pre-acceptance audits.
- When primary packages are collected individually from a producer they
  are placed into bulk containers (usually carts but also pallets for rigid
  containers) and the bulk container is tagged with a barcoded tag which is
  scanned into the tracking system). The barcoded tags can then be used to
  identify the bulk container in the tracking system and the route that the
  waste in the cart was received on.
- The primary packages within the cart are therefore traceable in the tracking system to the waste producers on that route, and each individual package can then be traced to the specific source using the tag, label or marking applied by the producer.
- When primary packages are removed from a cart for bulk transportation, the barcoded tags on those carts are assigned to a 'trailer sub-load' in the tracking system. The sub-load record can then be used to identify the carts that were emptied into the trailer, and therefore the individual producers or routes that the waste in those carts came from.
- The primary packages within the trailer are therefore traceable in the tracking system to this group of waste producers, and each individual package can then be traced to the specific source using the tag, label or marking applied by the producer.

The operator currently complies with all the storage segregation and handling appropriate measures given in the Healthcare waste: appropriate measures for permitted facilities guidance except for the following alternative measures were agreed for waste storage appropriate measure 11, we are satisfied that those measures provide an equivalent level of environmental protection:

The facility has a weatherproof roof that has been in operation since permit issue. This is however open on three sides and therefore does not meet the definition of a building.

The footprint of the facility completely limits any expansion or alteration of the facility to bring waste storage entirely within the definition of a building. It would not be technically feasible to construct any new waste storage buildings whilst maintaining safe vehicle access and egress

The following controls are in place which would provide an equivalent level of environmental protection for carts being stored outside:

- The containers remain closed and locked, except when waste is being loaded or unloaded from them
- Regular housekeeping checks and inspections are undertake of the storage areas, and any issues identified will be investigated and rectified.
- Odorous material is prioritised for treatment

- The waste containers are not accessible to pests, but pest control contracts are held at site.
- Waste is stored for a limited storage timescale.
- Routine and efficient turnover of waste (rotation).
- The site is secured via a locked gates outside of daytime working hours, is entirely made up of impermeable surfacing and has a sealed drainage system.

Unlike infectious waste, the requirement for Pharmaceutical, chemical, anatomical to be stored in a secure building is not a new requirement, it was in the previous guidance EPR 5.07 which we was relevant to incinerators too. We have set IC12 to ensure the operator complies meet. With Point 11 we have provided, in the guidance, the means to justify not meeting it for operators of existing facilities. However, we expect all operators to meet point 9.

#### 6.2 Emissions to water or sewer

The Operator provided details of a discharge to sewer. We are satisfied that the discharge is likely to be relatively small and any impacts on receiving waters are unlikely to be significant.

#### 6.3 Emergency release valve (ERV)

The plant has an ERV that is used in emergency situations. Our records show that the ERV operated 6 times between 2015 – 2022, including 3 times in 2021.

We have set improvements conditions IC6 to IC11 for the operator to review options (including provision of back-up power supply) to reduce its use and implement improvements if required.

#### 6.4 Determination of daily averages

We have included improvement condition IC5. This condition is for sites that have fairly frequent shut-downs. For some sites this means that a daily average cannot always be calculated due to not having enough valid hourly averages. The IC is designed to investigate whether a different number of valid hourly averages can be used to calculate a daily average. Having reviewed operating date we have concluded that we should set this IC for all of the SRCL permits.

#### 7 Review and assessment of derogation requests made by the operator in relation to BAT Conclusions which include an associated emission level (AEL) value

The IED enables a competent authority to allow derogations from BAT AELs stated in BAT Conclusions under specific circumstances as detailed under Article 15(4):

By way of derogation from paragraph 3, and without prejudice to Article 18, the competent authority may, in specific cases, set less strict emission limit values. Such a derogation may apply only where an assessment shows that the achievement of emission levels associated with the best available techniques as described in BAT conclusions would lead to disproportionately higher costs compared to the environmental benefits due to:

- (a) the geographical location or the local environmental conditions of the installation concerned; or
- (b) the technical characteristics of the installation concerned.

As part of their Regulation 61 Note response, the operator has not requested a derogation from compliance with any AEL values.

The guidance is clear at paragraph 1.5 that the growth duty does not legitimise non-compliance and its purpose is not to achieve or pursue economic growth at the expense of necessary protections.
	We consider the requirements and standards we have set in this permit are reasonable and necessary to avoid a risk of an unacceptable level of pollution. This also promotes growth amongst legitimate operators because the standards applied to the operator are consistent across businesses in this sector and have been set to achieve the required legislative standards.
