Thank you for your correspondence of 10 June 2021 in which you requested the following information:

'I would like to know:

1. How many officer cadets have started at BRNC Dartmouth each year in the years 2010 to 2020.

And, for those years:

2. Split by year, how many officer cadets entering BRNC each year were male and how many were female.

3. Split by year, how many officer cadets passed out / received their commission and entered full service, and how many did not (withdrew from service), for reasons including: medical discharge, voluntary discharge, compulsory discharge, other.

4. Split by year, of these officer cadets that received their commission/ passed out, how many were male and how many were female.

5. Split by year, of these officer cadets that did not receive their commission / enter the service and were discharged / withdrew from service, how many were male and how many were female.

6. Q5 broken down with reason for discharge- medical, voluntary, compulsory, other by year by gender'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that information in scope of your request is held and can be found at Annex A to this letter.
