Thank you for your correspondence of 6 July 2021 in which you requested the following information:

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held. With the exception of HMS SOUTHAMPTON's movements for the period January to August 1996 and January to October 2002 for which no recorded information is held, details of their movements for the other specified dates can be found at Annex A to this letter.
