

EXPORT OF DOGS AND CATS FROM THE UNITED KINGDOM TO ARGENTINA

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OVs) and exporters. The NFG should have been issued to you together with export certificate 3887EHC. The NFG should not be read as a standalone document but in conjunction with certificate 3887EHC. The NFG are based on the requirements for the importation of dogs and cats into Argentina, known to the Department as of January 2024. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each export.

1. **SCOPE OF THE CERTIFICATE**

Export health certificate 3887EHC may be used for the export of dogs and cats from the United Kingdom to Argentina.

2. **CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)**

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

- if the exported commodity is cattle, pigs, sheep, goats or camelids;
- if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: provision of certified copies

Authorised Private Veterinary Practitioners (aPVPs) certifying DAERA Export Certification On-Line (DECOL) produced EHCs must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the Department where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. **COMPLETING THE EXPORT HEALTH CERTIFICATE (EHC) FORM**

II. Origin of animals

Write name and full UK address of the exporter (owner or responsible person).

III. Means of Transport

Write means of transport for animals leaving the country of dispatch, and indicate its identification:

- aircraft (indicate the flight number);
- vessel (indicate the vessel name and number);

IV. Destination of animals

Write name and full destination address of the importer (owner or responsible person).

V. Health Information

1. Details of anti-rabies vaccination

Certify section a) if the animal(s) was/were vaccinated against rabies.

Certify section b) if the animal(s) are less than 90 days old and was/were not vaccinated against rabies.

Before signing the export health certificate, the OFFICIAL VETERINARIAN must be satisfied that the necessary vaccinations have been carried out. If vaccinations are carried out by another veterinary surgeon, the owner/exporter should provide evidence in the form of certificates. The vaccination certificate should be attached to the export health

certificate.

The non-applicable option should be struck through in the usual way.

2. Details of anti-parasite treatment

Enter the date of anti-parasite treatment, the manufacturer name and active ingredients. The treatment must be applied no more than 15 days before issuance of the certificate.

4. Other Vaccinations

This section should be used to enter additional vaccine information, if applicable. If this section is not applicable it may be struck through in the usual manner.

A separate schedule may be used if there is not sufficient space on the certificate to enter all required information. Schedules should be appended to the certificate and fan stamped in the usual manner.

5. Additional health information

This section should be used to enter details of additional treatments given in the 3 months prior to certification, if applicable. If this section is not applicable it may be struck through in the usual manner.

Separate schedules may be used if there is not sufficient space on the certificate to enter all required information. Schedules should be appended to the certificate and fan stamped in the usual manner.

5. Animals must be examined by the OFFICIAL VETERINARIAN not more than 10 days prior to the issue of the EHC.

4. WELFARE

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.
