Release of Information

Thank you for your correspondence of 13 July 2021 in which you requested the following information:

'Please send me the regulations and other documents dealing with the selection process, duties & pay for ship sponsors.

Please also provide a list of current ship sponsors if available.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held.

In response to part one of your request, I can advise that there are no official Terms of Reference for the role of Lady Sponsor. However, I can tell you that the Lady Sponsor role is derived from the Latin term for a guarantor or patron and was originally associated with person who presented a child for baptism; the Godparent, being the closest analogy. Historically the primary consideration when selecting a sponsor has been to seek a strong and enduring personal connection between the vessel and the sponsor to encourage a sustained and positive relationship, supporting the ship's moral profile. The list of existing and past sponsors dates back to 1953 and is exclusively made up of women. There is, however, no historical reason as to why the sponsor must be female; male sponsors were common into the 20th Century.

I can also confirm that Lady Sponsors are chosen by the Ships Names and Badges Committee and that they do not receive any pay for their role.
