Thank you for your email of 14 November 2023 to the Ministry of Defence (MOD) requesting the following information:

*"With respect to the Nuclear Test Medal, please can you let me know the number of numbers and nationalities of the foreign nationals who have received the medal?* 

Under the eligibility criteria this is listed as category (3): "(3) Foreign nationals who served at the locations where the UK atmospheric nuclear tests were conducted, including the preparatory and clear-up phases, between 1952 and 1967."

In addition, please can you let me know: A) the numbers and nationalities of of the civilian foreign nationals who were employed during operation Grapple

*B) if any outreach has been conducted to inform the Kiribati community that this medal has been launched* 

*C)* what accessibility measures have been taken into consideration to facilitate applications for the nuclear test medal from the Kiribati community"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that some of the information in scope of your request is held.

As of 21 November 2023, the Ministry of Defence Medal Office (MODMO) had dispatched 39 Nuclear Test Medals to Commonwealth Forces. All 39 individuals were New Zealand nationals.

No information is held in answer to parts A-C of your request.

Under Section 16 (Advice and Assistance) you may be interested to know that in addition to the 39 Nuclear Test Medals dispatched, as of 21 November 2023 the MODMO had received a further 152 applications for the medal from Commonwealth Forces. Of these, 8 cases had been approved with the medal still to be dispatched and 144 applications were still awaiting verification.

The Foreign, Commonwealth & Development Office (FCDO) may hold information to answer parts B and C of your request. In order to make a request for information you may wish to direct this part of your request to the FCDO at the address details below.
