



## Apply for an additional county parish holding number for your livestock business

Use this form to apply for an additional county parish holding (CPH) number if you will operate a separate holding within 10 miles of the main area you keep livestock.

You can apply for an additional CPH number if your livestock business has any:

- cattle, bison and buffalo (bovine animals)
- pigs
- goats
- sheep
- deer
- poultry (if you have 50 or more birds)

You must meet the conditions explained in Schedule 1 of this form.

## How to complete this form

You will need to:

- open the form in a PDF reader, such as Acrobat Reader
- download the form and save it to your computer
- complete all questions
- sign and date the form in part E this must be signed by the person named at question 2 in Part A. You can use a digital signature if you send us the completed form from the email address you've previously registered with APHA
- save the form again

### Submit a site plan

You must submit a site plan or map with this form, that shows both the existing and proposed additional holding. If the additional holding is part of the existing holding, show the boundaries of the two parts. For each holding, indicate a 'gathering point' where stock would be gathered for loading, management and inspection.

## What happens next

APHA may contact you to discuss your application. If APHA approves your application, the Rural Payment Agency (RPA) will allocate an additional CPH for you. You will receive a letter to confirm your CPH and your herd or flock mark (poultry do not need a flock mark).

#### Schedule 1

## Conditions you must meet to get an additional CPH for your livestock business:

- 1. The different parts of the business having different CPHs (the different holdings), must consist of different parcel(s) of land with distinct and described stock-proof boundaries.
- 2. Separate records must be kept.
- 3. The corresponding herds will be allocated separate herd marks.
- 4. Movements must be reported on/off each holding including movements between them.
- 5. Movements are subject to disease control standstill.
- 6. Movements of cattle are subject to TB pre-movement and post-movement testing requirements as appropriate to the country or region.

## If your additional holding will include cattle, you must also meet the following conditions:

- 7. The business must be officially tuberculosis free. The only exception is when acquiring a new business enterprise which will require its own CPH number.
- 8. There must be no direct contact of livestock on the different parts, with adequate distance separation and prevention of nose-to-nose contact with other livestock.
- 9. There must be no indirect contact through management practices or husbandry.

## There must be separate:

- handling
- · feed and water management
- equipment for example, feeding and mucking out equipment
- machinery
- facilities, where they are used on a regular basis, for example, milking parlours
- 10. There must be dedicated personnel for each of the different CPHs. Should personnel have access to other livestock outside the unit, a written protocol should also be submitted stating how often this takes place and how the biosecurity risk will be controlled. For example, separate clothing and footwear, livestock contact-free period between different units.
