Local Authority delivery support funding GRANT DETERMINATION 2023: *DLUHC reference number No 31/6870. DFE*

The Secretary of State for Education ("The SoS"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the **Local Authority (LA) delivery support funding** Determination 2023 [No31/6870].

LA delivery support funding is part of the expansion of the Early Years (EY) entitlement. LA delivery support funding is available this financial year (FY23-24) to support local authorities meet programme and delivery costs associated with rolling out the expanded EY entitlements.

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them, to effectively roll out the new expanded Early Years entitlements offer, and the obligations set out in the Memorandum of Understanding (MOU) between the SoS and all local authorities to which grants are to be paid.

Determination

3) The SoS determines the authorities to which grant is to be paid and the amount of grant to be paid.

LA NAME has been allocated £AMOUNT for FY23-24.

Payment of Grant

- 4) The grant shall be payable to local authorities in one instalment on or before 13 November 2023 (subject to the relevant MOU being signed by 26 October 2023).
- 5) For FY23-24, we have allocated this LA EY delivery support funding using a formula-based allocation which:
 - apportions funding based on each LA's share of the total PTE twoyear-old and under two-year-old pupil number estimate, as published alongside the <u>Early years funding - extension of the entitlements</u> consultation to give a 'population weighted funding' element to reflect variation in LA size.
 - includes an area cost adjustment (ACA) used in the current EY funding rates formula. This ensures the per-LA funding rates take into account the cost of delivery in different areas.

 has a minimum funding floor of £55,000 included, which will ensure every eligible LA receives a minimum level of funding for support to deliver the expanded entitlements.

Treasury consent

6) Before making this determination in relation to local authorities in England, the SoS obtained the consent of HM Treasury.

UK Government Branding

- 7) The Grant Recipient shall at all times during and following the end of the Funding Period:
 - 5.1 comply with requirements of the Branding Manual in relation to the Funded Activities; and
 - 5.2 cease use of the Funded by UK Government logo on demand if directed to do so by the Authority.
- 8) Branding Manual means the HM Government of the United Kingdom of Great Britain and Northern Ireland 'Funded by UK Government branding manual' first published by the Cabinet Office in November 2022 and is available at https://gcs.civilservice.gov.uk/guidance/marketing/branding-guidelines/ including any subsequent updates from time to time.
