#### Many of you informed us that you had lost large amounts of gear due to Storm Babet, or the gear had bundled together rendering it too heavy to lift.

## Regional updates and ongoing actions: WE DID

The Regional Fishers Group (RFG) team have partnered with two researchers from University of Oxford who are looking into seal depredation of catch around the UK, and we will be organising workshops with the industry over the coming months.

The RFG team have been in contact with 'Ghost Fishing' UK' who are a charity that are willing to help retrieve any lost gear and return this gear back to the owners.

## **Update from the North East Regional Fisheries Group:** Storm damage

Ghost Fishing UK is a British registered charity dedicated to removing abandoned, lost, and discarded fishing gear known as 'ghost gear'.

The organisation is completely independent and consists of over 70 volunteer divers working hard to tackle the problem of ghost gear. They have plenty of experience working with gear entanglements where there is just too much weight for the fishing vessel to safely haul their gear.

They first survey the site, then make a recovery plan and work out the safest way to get the gear safely to the surface.

They are careful not to further damage the fishing gear so that it can be returned to its owner with minimum repair.

# Grant funding opportunities - UK Seafood Fund support

Back in January 2023, Department for Environment, Food & Rural Affairs (Defra) announced an initial £2 million investment to trial new, greener engines and help create a safer, more sustainable fishing fleet.

This opportunity is available through Round 3 of the <u>UKSF Infrastructure scheme</u>.

Defra announced in December that they are expanding Round 3 to provide further support for the catching sector in **improvements to boats**, **ports**, **and health and safety**.

#### **MCA** consultation

On the 16 January 2024, the Maritime and Coastguard Agency (MCA) launched a 6-week public consultation on the possibility of exempting those who fished on vessels 10m and under for at least 4 weeks between 30 November 2022 - 30 November 2023, from the ILO188 medical certificate requirement.
