PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about poultry statistics, which the Animal and Plant Health Agency (APHA) received on 02 May 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

Original request:

I assume that the completed Poultry Register PDF's are loaded into some sort of information system? I understand that there is a lot of information which would be commercially sensitive or personal. However I would be interested in summary statistics, or preferably, an anonymous listing of the records in relation to Section 4 (Details of Bird Kept, except for the location where they are kept) associated with very limited information from Section 2 - specifically the business activity and, ideally, country (England, Wales, NIreland, Scotland).

Clarity of request:

Date Span: Current Records on the GB Poultry Register as of October 1st 2022 (this is not critical - July 1st 22 or December 31st 2022 are alternative suitable dates.

Area: GB

Data set: anonymous listing of the records in the poultry register re. Section 4 of the IRA81 form (All details of Bird Kept, except for the location where they are kept) associated with very limited information from Section 2 - specifically the business activity and, country (England, Wales, Scotland).

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

The information provided are the livestock numbers provided by the keeper upon registration. As part of the registration process, APHA ask the keeper what their usual stock numbers are, and this is recorded in the APHA database. It is the responsibility of the owner/keeper to keep APHA informed of any number changes.
