

## **HS2** INDEPENDENT DESIGN PANEL



### **Active Travel**

Active travel can support healthier lifestyles and help the UK to achieve its net zero carbon emissions by 2050 target.


In July, the panel met with the HS2 Active Travel team to discuss current workstreams. It stressed that like HS2 urban integration and green corridor workstreams, active travel has the potential to transform the public's understanding of the benefits HS2 – an important strand in delivering 'more than a railway'.

A compelling overarching vison for active travel will help people to understand what is possible and strengthen the justification of proposals. The panel encouraged HS2 Ltd to harness its shared knowledge and experience, as well as the benefits of an integrated approach across different workstreams, to strengthen the approach.

The delivery of active travel ambitions will often be the responsibility of others, such as local planning authorities. It is therefore important for HS2 Ltd to engage in open discussions with stakeholders and communities at an early stage. This should include communities who may typically feel excluded from active travel type conversations.

The panel is excited by the potential for HS2 to help stimulate a step change in active travel. It looks forward to supporting HS2 Ltd in realising opportunities along the line of route.

## Phase 2a

Later this year it is expected that HS2 Ltd will appoint a Design Delivery Partner (DDP) to manage and coordinate contracts on Phase 2a. Ahead of this appointment, the panel met with the Phase 2a team to understand how lessons from the project to date are informing the approach on Phase 2a.

The panel applauds the thorough and thoughtful approach HS2 Ltd has taken to identifying lessons and applying these insights to Phase 2a. It is confident that the processes, improved standards, more robust data, and tools can provide a robust platform for the next stage of decision making on Phase 2a. The panel also suggested identifying a measure that could provide insight into the cost, time and effort saved by learning lessons.

The success of the work will depend on how it is taken forward by the Phase 2a DDP. Careful thought should be given to the onboarding process and how the work done to date can help to drive a culture-shift across HS2 that can lead to the delivery of a truly place-based approach.

It is also important that HS2 Ltd has sufficient resources and governance mechanisms to hold the DDP to account. This will be essential to ensuring that concepts such as intelligent replication are approached judiciously and holistically, to achieve the projects design quality expectations.
