Thank you for your correspondence of 9 November 2020 in which in which you requested the following information:

'An up to date list of all technical contractors, subcontractors and suppliers involved in maintaining and supporting MOD submarine assets and infrastructure at Faslane naval base

I understand the list will be inaccurate and not comprehensive, however, I am happy with any data that you are able to provide without reaching the £600 limit.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information (FOI) Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held by the Department. However, as we explained in our previous correspondence, reference FOI2020/11344 dated 5 November, in order to remain within the cost limit of the FOI Act, we are only able to provide you with a list of HM Naval Base Clyde's Principal Industry Partners. This list can be found at Annex A to this letter.
