ELECTRICITY GENERATING STATIONS (VARIATION OF CONSENTS) (ENGLAND AND WALES) REGULATIONS 2013 (AS AMENDED)

KEADBY II POWER STATION PROJECT, KEADBY POWER STATION SITE, TRENTSIDE, KEADBY, NEAR SCUNTHORPE, NORTH LINCOLNSHIRE

I refer to the variation made on 1 March 2019 by the Secretary of State for Business, Energy and Industrial Strategy (“the Secretary of State”) on the application of Keadby Developments Limited (“the Applicant”) to the consent under section 36 of the Electricity Act 1989 (“the Act”) dated 10 September 1993, as varied on 3 November 2016 (“the 2016 variation”) and 21 December 2017 (“the 2017 variation”) under section 36C of the Act (“section 36 consent”), to construct and operate the Keadby II combined cycle gas turbine (“CCGT”) generating station at Trentside, Keadby, North Lincolnshire (“the Development”). It also varied a direction (“section 90 direction”) under section 90(2ZA) of the Town and Country Planning Act 1990 that deemed planning permission for the Development.

It has been brought to the Secretary of State’s attention by the Applicant, that, due to a typographical error, an incorrect “Multi-Shaft Layout Plan Drawing Number” reference was included in Condition (13) of the issued deemed planning permission conditions: the consented version issued on 1 March 2019 incorrectly referred to “Multi-Shaft Layout Plan Number 105_0805_0030 Rev 02” rather than “Multi-Shaft Layout Plan Number 105_0805_0035 Sheet 01 Rev 02”.

A corrected version of the varied consent document issued on 1 March 2019 is attached with this letter. For the avoidance of doubt, this letter confirms that the Multi-Shaft Layout Plan Drawing referred to in Condition (13) should itself be referred to (with tracked changes) as follows:
