

If your application is successful, the co-respondent has a legal duty under Section 73(1)(b)(i) of the Companies Act 2006 to take all steps as are within their power to make, or facilitate the making of, a change of name to one which is not an offending name. If, by the date ordered, the name is not changed to one which is not an offending name, the Adjudicator may determine a new name for the company. Under Section 73(1)(b)(ii) of the Act, the co-respondent has a legal duty not to cause or permit any steps to be taken calculated to result in another company being registered with an offending name; this includes the current company. If the application is successful, the co-respondent will be liable for costs, jointly and severally, with the company (i.e. the primary respondent).
