Release of Information

Further to our letter dated 24 February 2021, I am now in a position to respond to your request for the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information from the Royal Navy. Please may you provide me with:

• A breakdown of the sum costs associated with deploying the River Class offshore patrol boats (Operational Patrol Vessels) for the purposes of ensuring that fishing boats from EU member states did not enter the UK's Exclusive Economic Zone at the end of the transition period following the UK's exit from the EU. This should cover the period from 30.12.2020 until 27.01.2021 (when ships mobilised, to the operation being wound down).

• A breakdown of the sum costs associated with having a) offshore patrol vessels and b) Armed Forces personnel on standby for the duration of the period that a) offshore patrol vessels and b) Armed Forces personnel were put on standby, to the date a) offshore patrol vessels and b) Armed Forces personnel were sent.

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information (FOI) Act 2000.

As explained in our interim response, a search was completed within the Ministry of Defence (MOD) and it was confirmed that some information in scope of your request was held. However, in that same correspondence, we also informed you some of the information requested may be exempt under Section 27 (International Relations) of the FOI Act. After further consideration of the information in scope of your request, it has been determined that the exemption does not apply on this occasion

Therefore, some information to answer your request in respect of the assets deployed and on standby in support of the Marine Management Organisation (MMO) can be found at Annex A to this letter.

Under section 16 (Advice and Assistance) of the FOI Act, you may find it useful to know that the Royal Navy does not maintain vessels exclusively employed for fishery patrol activities; Fishery Protection policy and enforcement is managed by the Department for Environment, Food and Rural Affairs (DEFRA). The MOD has an agreement to provide a dedicated number of enforcement days with the MMO, an agency of DEFRA responsible for Marine Enforcement in English territorial waters and the Exclusive Economic Zone.
