Between 8 June 2020 and 19 March 2021 how many Royal Fleet Auxiliary seagoing personnel returned to the UK:

A. From ships deployed overseas to return to their home address.

B. From home addresses overseas to join ships in the UK.

C. How many people in paragraph A were instructed by the Royal Fleet Auxiliary to undertake self isolation in accordance with the The Health Protection (Coronavirus, International Travel) (England) Regulations 2020.

D. How many people in paragraph B were instructed by the Royal Fleet Auxiliary to undertake self isolation in accordance with the The Health Protection (Coronavirus, International Travel) (England) Regulations 2020.

E. If applicable why were those detailed in paragraph A not instructed to self isolate. F. If applicable why were those detailed in paragraph B not to instructed to self isolate.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information (FOI) Act 2000.

1. Tidesurge in refit during the period specified

2. Tidespring not deployed during the period specified. Less than five personnel listed reside at overseas addresses.

3. Tiderace(E). A number were instructed no requirement due to Defence Exemption. (F). Majority went by the Government website and isolated accordingly with family or at Hotels.

4. Tideforce(B). Less than five persons with overseas addresses joined within the timeframe specified. (D). Joining instructions stating the requirement to self- isolate were emailed to all persons regardless of country of origin.

 Cardigan Bay(C). 7 RFA personnel in Feb 21 were instructed to self-isolate. This was as a result of the exemption for Merchant Seafarers previously applied being withdrawn by the MoD and DAN 18 not yet being validated for use by RFA personnel. (E). For period Mar 20 – Feb 21 RFA Personnel were instructed to apply self-isolation exemption in accordance with Merchant Seafarer Status.

For the period Feb 21 – present RFA Personnel have been exempt from requirement to self-isolate upon arrival in the UK in accordance with DAN 18 / letters of exemption issued by COMOPS / COMRFA.

6. Mounts Bay/Wave Knight/Fort Victoria not deployed during the period specified.
