General Discussion Points

High Quality Trust Framework (HQTF)

• Looked at the commissioning process as set out in the HQTF, which will help to identify the right trust for each school, taking into account the local context and to be more transparent on decision making.

LA overview

- LA overview provided for Barnet, Kensington & Chelsea, Hackney, and Lambeth.
- Discussed challenges around high needs funding.
- Discussed challenges of surplus school places in London, particularly at primary stage.

Converter Academy Orders

Points discussed in relation to school conversion.

Project: To discuss the conversion of Osidge Primary School, Barnet - to join Ashmole Trust, Barnet

AB discussion: Osidge Primary School is a 2FE Community school in Barnet with 415 pupils on roll aged 4 -11. It has applied to convert to academy status and join Ashmole Trust. Osidge Primary was inspected by Ofsted in June 2018 and was judged good.

Ashmole Trust is a small two school trust with strong educational performance. The two schools in the trust are: Ashmole Academy and Ashmole Primary School.

Ashmole Academy is part of the department's Behaviour Hub programme, where it provides support, training and advice to improve behaviour culture in schools.

Both Ashmole trust and Osidge School are currently working in collaboration where they share resources such as teaching expertise and staff development.

AB members discussed performance at the schools and the trust's school improvement plan.

AB members discussed trust finances.

RD decision: Approve

Conflicts: None

Further actions required: Inform the school, trust and local authority of the decision.

Project: To discuss the conversion of Loughborough Primary School, Lambeth - to join The Charter Schools Educational Trust, Southwark.

AB discussion: Loughborough Primary School is a 1FE Community school in Lambeth with 320 pupils on roll aged 2 -11. It has applied to convert to academy status and join The Charter Schools Educational Trust (TCSET). Loughborough Primary School was judged good by Ofsted.

AB member discussed school's performance data and the trust's school improvement strategy.

AB members discussed school's finances.

Recommendation for an SRMA deployment for TCSET.

RD decision: Approve

Conflicts: Cassie Buchanan, CEO of The Charter Schools Educational Trust, was not present for this item and did not receive the papers.

Further actions required: Inform the school, trust and local authority of the decision, and to seek a plan from TCSET for financial recovery and growth going forward, working with Loughborough Primary School.

Significant Change

Points discussed in relation to significant changes application(s).

Project: To discuss Parkwood Hall Co-Operative Academy (singleacademy trust), Kensington and Chelsea - physical expansion of premises of a special school.

AB discussion: Parkwood Hall Co-Operative Academy (PWH) is a single academy trust operating in Kent as a special school, including some residential pupils, for children aged 8-19.

PWH are requesting an increase in their capacity from 80 pupils to 120 to reflect the high demand for places.

PWH currently accepts students from around 16 Local Authorities across London and Kent.

Pupils at the school have a variety of disabilities with significant number of pupils having an Autism Spectrum Disorder.

AB members discussed risks.

RD decision: Approve

Conflicts: None

Further actions required: Inform the school, trust and local authority of the decision, and to seek a response from the trust on how they will ensure safeguarding both at trust level and LA level.

Project: To discuss The Bridge Academy (single-academy trust), Hackney - opening an Additional Resource Provision.

AB discussion: The Bridge Academy is a co-educational secondary school with a sixth form located within the London Borough of Hackney, with a capacity of 1150, including a sixth form of up to 250 pupils.

The Bridge Academy, with the support of the local authority, are seeking to develop an Additional Resource Provision (ARP) for 15 pupils with Education Health and Care Plans (EHCPs).

The provision will grow incrementally each year.

Recommendation for a SRMA deployment.

Further actions required: Inform the school, trust and local authority of the decision and, to understand the trust/ LA's strategy for demand on places at the ARP.
