“Are you discussing genocide?”: Injunction Injustice targets DLA Piper

Press / December 7, 2023

Five people from Injunction Injustice disrupted a corporate presentation event at the offices of the law firm DLA Piper on Tuesday evening before they were ejected by security guards. The city law firm is profiting the most from the civil law injunctions brought by the government against Insulate Britain, Stop HS2 and Just Stop Oil. [1]

Tuesday evening at around 6pm, five people from Injunction Injustice stood outside the DLA Piper and Times newspaper sponsored event ‘A Year In Review’ at 160 Aldersgate, London. They displayed banners, spoke to guests and at one point entered the foyer of the building before they were forcibly ejected by security guards. Guests included lawyers, consultants and DLA Piper clients from The Times, The Telegraph, the Spectator and The Guardian amongst others.

The Injunction Injustice supporters were raising awareness of the role of law firms such as DLA Piper in helping the government to silence dissent and repress peaceful protest through the means of civil injunctions. As well as criminal charges, incarceration and tagging, climate defenders who may have breached an injunction simply by standing outside an oil terminal with a sign, face oppressive financial costs.

The use of injunctions is having a chilling effect on peaceful protest; protest against new oil and gas licensing which will kill hundreds of millions of people. Scientists warn of untold suffering and death, of the collapse of whole nations, and the eradication by manmade global heating of entire peoples and cultures. New oil and gas means genocide and lawyers who are supporting the government in suppressing protest are complicit.

Injunction Injustice supporter Karen Wildin said:

"The role of lawyers and journalists is critical in these times. Most don't seem to want to acknowledge this, probably because it requires significant shifts of attitude and mindset. However, they have huge power and therefore huge responsibility."

"The most important thing any of us can do is acknowledge that business as usual is killing us. If we continue down the current path we face annihilation. This is especially true for young people and those in the global south for whom continuing with our fossil fuel addiction means genocide."

"We asked the participants are you discussing genocide tonight ? And if not, why not ?"

Injunction Injustice was started by people who have previously taken action with Just Stop Oil but who are now banned from participating in Just Stop Oil actions by draconian bail conditions.

A spokesperson for Just Stop Oil said

"More and more ordinary people understand what these lawyers apparently do not and that is that no-one is safe from the consequences of runaway global heating. Your fat salary might give you a few months respite from extreme heat waves and mass crop failure, but in the end we will all see our children starve and have to face riots and war."

"Why, then, are lawyers aiding and abetting our criminal government in persecuting ordinary people trying to protect humanity when we should all be working together to deal with the impacts of climate breakdown and societal collapse? Lawyers must be responsible. Stop profiting from genocide"



DLA Piper is an international Law firm that claims to have green credentials and yet they are the firm profiting the most from the civil law injunctions brought by the government against Insulate Britain, Stop HS2 and Just Stop Oil.

Lawyers for DLA Piper charge the government between £90 and £412 per hour for their services, fees which the government then seeks to recoup from the people named on injunctions in the form of legal costs. For example, lawyers acting for the government in respect of the National Highways Ltd M25 injunction originally sought costs of £727,574 against the 133 defendants. People named on injunctions are frequently faced with huge legal bills whether or not they broke the injunction. [2]

In addition to legal costs running to tens of thousands, those convicted of breaking an injunction face up to 2 years in prison, an unlimited fine and seizure of assets. Many of those in court this week have already spent long periods on remand, experienced restrictive bail conditions and ankle tags and, in an apparent case of double jeopardy face trial for public nuisance in criminal courts in 2024/5. Continued expansion of new oil and gas will bring about the wholesale destruction of ordered society and an end to the rule of law. We are not prepared to watch while the government continues to serve the interests of a few, at the expense of everyone else. It's up to all of us to come together and resist. It is the will of the overwhelming majority of people that we take the actions necessary to ensure our survival and together we can make it happen.

Our government is waging war on its people, and we're fighting back. They're the real criminals – imprisoning peaceful people for taking proportionate action to protect their communities, whilst licensing more than 100 new oil and gas projects, which will destroy everything we value. We're coming together to demand an end to new oil and gas. It's not a case of 'if' we will win; but 'when'.



At Fradley Junction , the spur to phase 2b was silent with no work . Broken Down Wood has had its middle totally removed. The substantial section of Fradley woods that was destroyed is now a silent store for sands and aggregate.

Along the canal path heading to the ravaged Ravenshaw Wood are the remnants of where a community of humans lived low carbon lifestyles as boaters with allotments along this jetty. The lock keepers cottage is Heras fenced off and empty.

Many silver birch saplings, with dead tree stumps interspersed, can be seen where the cutting machines and security vehicles used to be stored for tearing out the heart of Ravenshaw Wood where the ancient deer herds fled from there to Fradley Village one foggy morning in Feb 2021.

Camp Isla is now a new but empty compound . Opposite, the house is gone and so is what was the temporary compound. Just a green 6 ft security fence and nature reclaiming flattened land where there was previously thriving hedges and a diverse mix of mature trees.

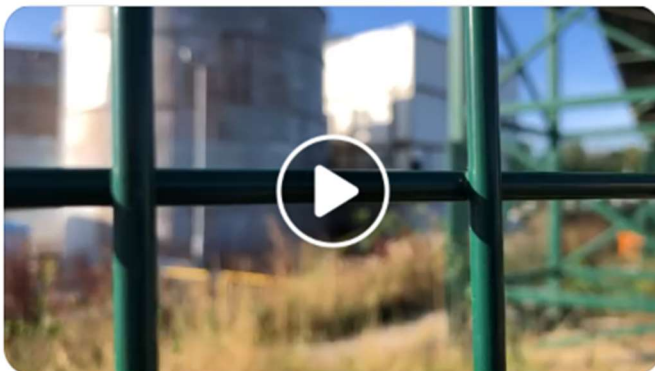

A protester who climbed onto the roof of a city centre office block has been arrested and lowered down on a cherry picker.

The man, a pro-Palestine demonstrator, climbed onto the roof of Centurion House on [Deansgate](#) this morning (November 22). The man, who started the protest shortly after 8am according to police, was arrested and lowered down in the mid-afternoon.

Images of the protest have been shared on social media. They showed a group of people holding Palestinian flags and banners, while the protester shouted messages from the roof.

The group, Manchester Palestine Action, said the building was targeted because it houses offices for Fisher German, a property firm which rents out offices for Elbit Systems, a weapons company. The man was brought down via a cherry picker from the roof of the entrance, and was then arrested.

A statement from [Greater Manchester Police](#) said: "Shortly after 8am today (Wednesday 22 November 2023), officers were called to reports of a man on the roof of a premises in Deansgate, Manchester. Officers engaged with a man, who has since been arrested on suspicion of aggravated trespass."

At Fradley Junction , the spur to phase 2b was silent with no work . Broken Down Wood has had its middle totally removed. The substantial section of Fradley woods that was destroyed is now a silent store for sands and aggregate.

Along the canal path heading to the ravaged Ravenshaw Wood are the remnants of where a community of humans lived low carbon lifestyles as boaters with allotments along this jetty. The lock keepers cottage is Heras fenced off and empty.

Many silver birch saplings, with dead tree stumps interspersed, can be seen where the cutting machines and security vehicles used to be stored for tearing out the heart of Ravenshaw Wood where the ancient deer herds fled from there to Fradley Village one foggy morning in Feb 2021.

Camp Isla is now a new but empty compound . Opposite, the house is gone and so is what was the temporary compound. Just a green 6 ft security fence and nature reclaiming flattened land where there was previously thriving hedges and a diverse mix of mature trees.

Urban explorers on hospital roof spark police op

Dozens of police officers were called to the Royal Sussex County Hospital last night after urban explorers got on to the roof of the empty Barry Building.

The 1820s Georgian era building at the heart of the hospital complex is due to be demolished now that the new Louisa Martindale Building has opened.

The video was streamed live last night on Facebook by an account called Mr Airborne and features a man wearing black clothing and hat and a woman with red hair who he calls Becks.

The man said: "The security on this place is mental. It's took us so long to get in here. We had to wait until it gets dark to even give us half a chance.

"We did get caught by a member of the public on the way in. I think we probably are going to get caught because security are in the building. But this place is mental."



After about 40 minutes exploring, by which time they're on the roof, the man spots security guards, saying: "There's loads of them. F*** it. Right guys, we're caught." He then mutes the feed briefly.

When the video starts, he realises police officers are also on the roof asking them to come down.



At one point, a police officer trips on a drain hole on the roof and the woman explorer almost does the same.

The pair then come back in through a window and are led down to the ground floor, where they exit the building.



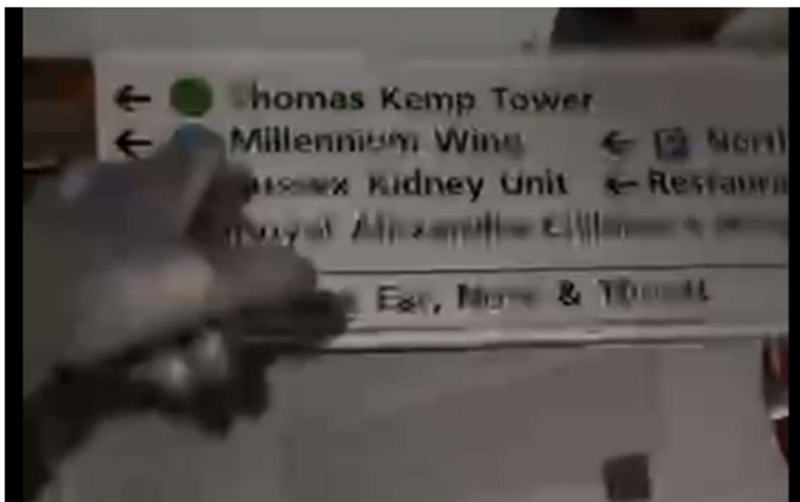
A police officer is heard telling them: "If you do this sort of thing a lot, then you'll understand ..."



Another officer is heard saying "What a waste of time" and a third said: "Don't, because if you fall off, then we have to come and scoop you up."

The first officer said: "We're satisfied you're not up to anything sinister. You're not coming equipped to steal stuff."

The male explorer said: "Nice one mate, see you later." He then walked off.



Sussex Police said: "Police were called to the Royal Sussex County Hospital yesterday (Monday 8 January) at around 6.15pm following reports of two people on the roof of the building.

"Security located a man and woman on the roof and they were removed from the area.

"No arrests were made."

An urban explorer plunged 20 feet to his death when he fell through the roof of an abandoned dairy building, an inquest heard today.

Ethan Bonnar, 22, suffered a traumatic brain injury after dropping through a sky light in the roof of the disused warehouse in Totnes, Devon.

The student, born in Scotland, had been reported missing but was found a day later in the building, having fallen 20 feet through a roof onto a concrete floor.

Ethan, who was studying an illustration course at Plymouth University, loved climbing and exploring abandoned buildings, said his girlfriend Charlotte Rose.

The student, born in Scotland, loved climbing and exploring abandoned buildings, said his girlfriend Charlotte Rose

She said Ethan would explore either alone, with her or friends, adding: 'He did this not to cause damage but to take pictures and videos because he appreciated the aesthetic.'

A woman introduced them to the Urban Explorer forum and in July last year he decided to go to the old dairy site in Totnes and sent Charlotte a video from the roof of the building.

Charlotte said she had no more contact from Greenock-born Ethan and later contacted his mother, Cheryl Reynolds.

They reported him missing to the police and sent officers the video Ethan had taken.

Police searched the old dairy and found Ethan unconscious. He died later in a Plymouth hospital.

Detective Sergeant Andy Penhaligon told the inquest: 'No third party was present at the time Ethan fell through the roof.'

'It appeared to be a tragic accident.'

Ethan's mother Cheryl, from Torquay, Devon, issued a warning to others about the dangers of urban exploring at the time of her son's death.

She said: 'What he did was so dangerous. I just want this message to get out there that these young people just don't realise how dangerous it is in these old buildings.'

'I told Ethan not to do it and I told him he was being an idiot but he always thought he would be okay.'

Judge's bid to stop urban explorers entering a construction site set to have tallest cranes in the City of London

A High Court judge has moved to stop urban explorers entering a construction site expected to feature the tallest cranes in the City of London.

Mrs Justice Stacey has made an order against 'persons unknown' after a construction firm creating a 155-metre tall building in Leadenhall Street took legal action.

A barrister representing Mace Limited said there had been 'no known incursions' at the site but told the judge about 'seven instances of urban explorer trespass' at other Mace sites across London.

Mrs Justice Stacey granted Mace's application for an injunction to 'restrain trespass'.

She said in her ruling: 'The pattern of behaviour and bravado of urban explorers in relation to other notable London sites in the past two years leads me to conclude that the probability of a trespass is not only imminent and real, but also high.'

She added: 'The risk of death or serious injury from an urban explorer trespass at the site is both real and would be grave and irreparable as demonstrated by the number of deaths of urban explorers over the past six years.'

'The last thing he sent was this video of him on top of the roof.

'Ethan had a heart of gold, he was such a likeable, positive, outgoing person.'

The senior Plymouth and south Devon coroner Ian Arrow recorded a conclusion of accidental death.

He said: 'He went to a derelict building and while exploring that building he has fallen through the skylight and landed heavily on the concrete floor below.

'Ethan was clearly a content person who liked exploring.'

TikTok ghouls who filmed Nicola Bulley's body being pulled from the river is 'fraudster who tricked women into taking gym pictures'

- Curtis Arnold, 34, duped police officers on the day the mother-of-two's body
- He has received swathes of criticism, and is now revealed as reported trickster

A **TikTok** ghouls who secretly filmed **Nicola Bulley's** body being retrieved from the river is reportedly a fraudster who tricked women into taking gym pictures.

Curtis Arnold, 34, barged his way into the official press area and duped police officers on the day the mother-of-two's body was found before posting the distasteful content to his online accounts.

The barber, who has no journalistic credentials, insists he is offering 'media and journalism done differently' to 'help get justice for those who can't'.

But he has received swathes of fierce criticism over the grim footage of officers using a body bag on the water's edge, with his social media channels also including a number of hurtful and scandalous headlines about Ms Bulley's case.

And Arnold is also a 'narcissistic' and 'manipulative' trickster with a number of previous criminal convictions - including drink driving, burglary and fraud, **The Sun** reports.



His most recent criminal conviction is said to have come for a fraud charge in 2018, for which he served a custodial sentence, while his criminality stretches back to when he was in his 20s.

Arnold also reportedly posed as a fitness modelling agent and visited a number of gyms across London under the guise of being on the search for female models to promote a range of leggings.

Instead, though, he is said to have taken a number of sexualised photos and videos before sharing them on social media without permission to promote his own fitness products.

Arnold reportedly served his sentence at HMP Wormwood Scrubs following a conviction for fraud by false representation, where he was said to have been unpopular with staff.

A prison source told The Sun: 'He was a very narcissistic, manipulative individual and would regularly try to manipulate female staff, especially education staff.'

'He was slimy and would tell them they were beautiful or he preferred them over another officer.'

'He would say very inappropriate things and would ask for their mobile numbers and ask to see them outside of the prison.'

'But when he started asking female staff to smuggle in phones and drugs for him, it all went down on his report.'

Arnold was reportedly sacked from a reception orderly role after it was alleged he was 'part of a group smuggling items' into the prison.

He is also said to have been handed a six-month suspended sentence at Hereford Crown Court in March 2010 for perverting the course of justice after altering his car's registration plate.

The barber returned to court in October later the same year reportedly for breaching the suspended sentence for drink driving on the M6.

In November, he is said to have admitted receiving two stolen registration plates.

He is also understood to have broken into the garage of a property and stolen tools in Kidderminster, before pleading guilty to burglary.

But Arnold reportedly avoided a stint in prison after the judge said he had shown signs of maturity

Now Arnold has received widespread backlash and public anger after posting footage of the ashen-faced couple in shock after finding 45-year-old mother-of-two Nicola's body in reeds by the River Wyre on February 19.

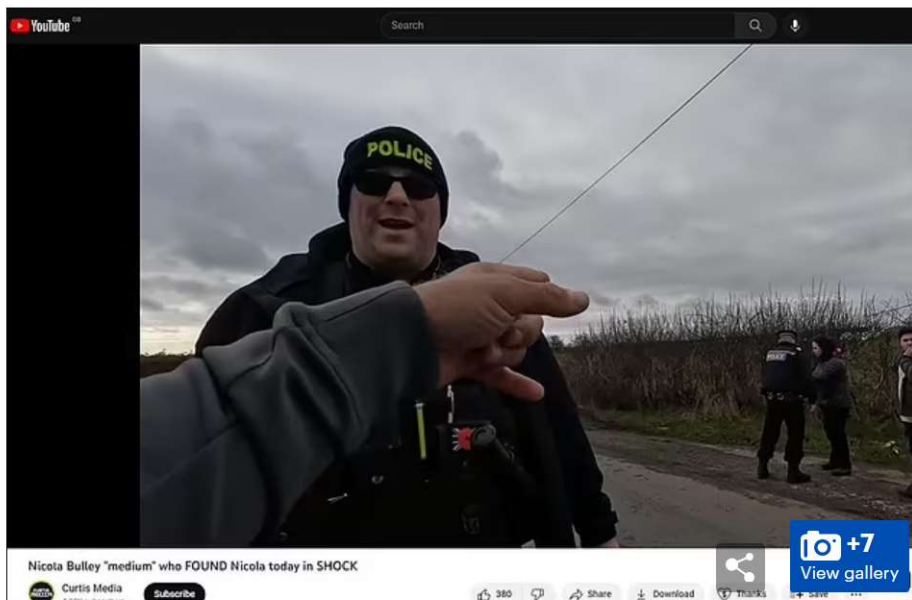
The athletically-built powerlifter makes regular six-hour round trips from his Worcestershire home to St Michael's on Wyre, Lancashire, and films with a GoPro camera strapped to his chest.

His latest video was posted on Saturday - the day after he was unmasked as being the sleuth behind the sickening eight-minute clip.

It opens with Arnold driving back to the village, saying: 'This is actually the drive that you would have to do if you were going to transport anything - AKA perhaps Nicola - to the location.'

He continues: 'Most of the country are speculating that possibly Nicola was not in that river the whole time.'

Showing a shallow section of the River Wyre close up, Arnold adds: 'Is that what the police want us to believe that she was in there all this time?'

Arnold then films canoes and a boat lying abandoned in nearby fields, before suggesting they could have been used to move a body during a 25-minute video already watched 60,000 times on YouTube alone.

Arnold has so far earned almost £1,000 in royalties from his channels covering the case.

His footage - possibly the most controversial and distasteful of all the material that has swamped TikTok and YouTube in the wake of Ms Bulley's disappearance a month ago - attracted nearly a million views.

The most sickening was footage covertly taken of police retrieving Ms Bulley's body from the River Wyre.

Earlier, he was asked to turn back while walking along a nearby road, but duped

Earlier, he was asked to turn back while walking along a nearby road, but duped an officer into letting him through by claiming that he needs to return to his parked car and saying that he is from Blackpool.

As dozens of officers gathered and a police helicopter and drone hovered overhead, Arnold asked a female police officer: 'What's going on down there? I've walked down and he wouldn't let me pass'.

She also directed him to leave the area, but the video then cuts to Arnold filming covertly as officers at the side of the river.

But who exactly is Curtis?

The Mail tracked Curtis down from his digital footprint to a town centre barber's shop in the Midlands.

Inside was an athletically built young man in a tight-fitting T-shirt, knee-length shorts and trainers, clipping the hair of a middle-aged customer.



Asked if he was behind the notorious video, he replied 'Yes. How did you find me?'

He admitted that he lied to police and crouched in a field to film covertly on his Samsung S21 smartphone.

Arnold is single and lives in a three-bedroom detached house near the barber's shop he has been running for the past two years.

He made five six-hour round trips to St Michael's on Wyre in the space of ten days to acquire 'content' for his channel.

The barber gleefully revealed the £716.06 in royalties that he made from YouTube alone, adding: 'It is probably £900 by now but it takes a while to come through.'

'My ambition is to be a full-time YouTuber and make a good living from it. The income potential is there and I love doing what I am doing on the channel.'

His first viral videos were of 'car fishing' - vehicles coming unstuck attempting to drive through deep water - at Rufford ford near Newark, Nottinghamshire.

Someone who knows Arnold well said: 'He was not making any money initially and was desperate to monetise his car fishing "fail" videos. He will do anything for more views to make money.'

'He gives all TikTok-ers a bad reputation. He is not reporting news. What he is doing is monetising people's peril or anything else he can. This all needs regulating properly. It's like the Wild West.'

Arnold tried to justify smearing the reputation of Nicola's grief-stricken partner Mr Ansell, saying: 'I felt he was hiding something when I watched him being interviewed on TV.'

'I was hoping my videos would trigger a member of the public to come forward with new information.'

Another of his videos about Ms Bulley has been viewed almost 100,000 times on YouTube.

He has also been criticised for a video he uploaded to another of his channels, 'Curtis Cool Stuff', on February 18 of a 'possible burial site'.

Arnold claims that his covert filming triggered death threats.

He said: 'I know that has caused a lot of controversy and if it has caused her family any distress, I apologise.'

'If they saw it, it can't have been a nice thing for them to have seen and I'm sorry about that.'

But he remains undeterred: "I intend to follow as many breaking news stories as I can in the future and put them on the channel.

'It gives the public a chance to get closer to the event and in the Nicola case I wanted people to watch my footage and see if they noticed that me or the police had missed anything.'

Experts say that social media algorithms encourage and reward controversial content like Arnold's.

There have been 400 million views on TikTok alone of videos with the hashtag 'NicolaBulley'.

They include over half a million views of 26-year-old 'psychic' Lucy Hesford-Buckingham, from Wales, sharing her vision on the case before Nicola's body was found.

In her video, she claimed that she sensed intuitively from an 'overwhelming smell of lemon bleach' that Nicola was still alive but being held captive and in 'severe danger'.

So many sleuths descended on St Michael's on Wyre that, at one point, police had to issue a 48-hour dispersal order to clear the village of outsiders.

TikTok insists that it removes content and accounts that engage in bullying and harassment or otherwise violate its policies.

Met officers make record number of arrests to keep London moving



A total of 657 arrests were made over the last five weeks as our officers worked to keep London moving in the face of JSO disruption.

Just Stop Oil activists also faced 338 charges as a result of dozens of attempts to bring the capital to a standstill.

We believe this is the highest number of arrests ever made in response to mass unlawful disruption.

A further 308 activists remain on bail accused of offences including interfering with national infrastructure, ahead of further charging decisions.

Some individuals were arrested multiple times and face multiple charges.

The five-week operation cost at least £3.5m and led to 10,500 officer shifts being taken away from communities.

The total cost of policing Just Stop Oil protests since October 2022 is now £19.9 million.

Commander Kyle Gordon, who oversaw the operation, said: “Community policing is at the forefront of the Met’s priorities and it is tough to see resources being taken away from our boroughs by Just Stop Oil.

“These officers should be responding to local communities and dealing with local issues instead of being taken away to police Just Stop Oil protests. Their time could be far better spent tackling issues in our communities and keeping them safe.

“We understand that in a democratic society there is a strong presumption in favour of the right to protest, but we also have to consider the rights of those who are impacted by JSO’s actions. While there is a right to protest and have your voice

heard, there is no right to cause sustained serious disruption.

“It is Londoners who ultimately face the brunt and bill for this action and we understand the frustration of Londoners who are caught up in the disruption, which as we know from previous campaigns impacts on everything from a school run or commute to work through to issues such as attending hospital appointments.

“Our response has successfully minimised the disruption for the majority of Londoners going about their lives, but I urge anyone who was impacted to contact us.

“This is a busy time for Met officers and I also want thank them for their commitment to minimising JSOs disruption by effectively using the new legislation.”

Our aim in response to Just Stop Oil’s activity was to keep London moving and reduce serious disruption.

We used new legislation (section seven of the Public Order Act 2023) to arrest activists and remove them from roads.

On one occasion we made 79 arrests within 20 minutes to clear Whitehall.

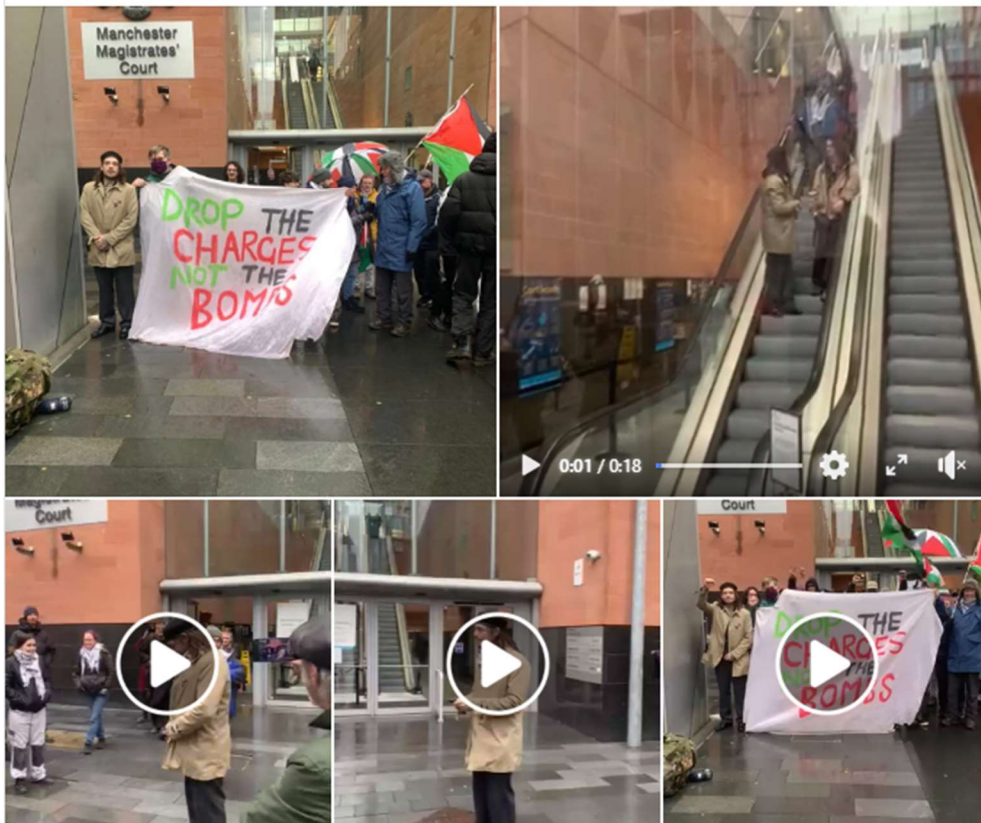

Today, as the death toll in Gaza passed 20000, I attended Manchester magistrates court to plead NOT GUILTY to charges ranging from criminal damage to aggravated trespass against Fisher German, after I occupied the rooftop of their building some weeks back. My case has been listed for trial next December 2024. My actions were part of a wider campaign against fisher German and their links with Elbit systems. Elbit systems is Israel's largest weapons manufacturer and its weapons are being used to murder, collectively punish and ethnically cleanse the population of Palestine right now! Since the rooftop occupation, Fisher German has announced that they have divested from working with Elbit systems and its subsidiary factory UAV (unmanned aerial vehicles) engines. This comes following Palestine Actions two and a half year campaign against the Landlord company as well as being targeted by other groups such as YFFP (youth front for Palestine) and Manchester Palestine Action.

Louis McKechnie is the face that launched a thousand British football memes. In March, the 21-year-old caused a stop to play when he ran onto the pitch at Goodison Park during [a match between Everton and Newcastle](#) and zip-tied himself to a goalpost by his neck.

If anything could have enraged the 40,000 jeering football fans more, it was the solemnity with which he did it. But while for many the episode will have merely been jotted down as another entry in the annals of absurdity, his cause was deadly serious.

A day earlier, Maddie, 21, and Kai, 20 – who did not give their surnames – attempted to stage a similar action at Arsenal’s Emirates Stadium in north London. Kai took a long pause and looked around him at the slowly filling stands before describing how he felt about what they had planned.

“Every single second I spend here, I want to do what I’m going to do less, because I can see everyone just trying to have a nice time,” he said. “But I know it’s what is right; I know that it has to happen.”

Fuel to the fire

Louis, Maddie and Kai are all young activists with a climate group called Just Stop Oil. They have called on the UK government to halt all new fossil fuel projects in order to avoid the worst effects of climate change. If their efforts fail, they intend to paralyse the supply chain themselves, using non-violent direct action to disrupt the strategic oil and gas infrastructure that keeps the UK moving.

The ambition is big. “We are mobilising upwards of 1,000 people,” one JSO activist told the Guardian. “This is going to be a fusion of other large-scale blockade-style actions you have seen in the past.”

Just Stop Oil say they are taking inspiration from UK lorry drivers’ protests in 2000, when, furious at a rise in fuel duty, hauliers and farmers staged blockades that paralysed petrol distribution. **Hundreds of petrol stations ran dry**, leading to empty shelves in supermarkets, delays to mail deliveries and schools being closed. Protests ended after the government said it would order soldiers to secure deliveries, but they won: then-chancellor Gordon Brown announced in that year’s budget that fuel duty would be frozen.

But where 20 years ago those protesters enjoyed public support in their campaign against rising prices, Just Stop Oil’s target is the fossil fuel system itself. While polling shows large majorities regard the climate as one of the most important issues of the moment, it’s unclear whether that understanding would continue if the pumps were empty.

At a recruitment meeting last Thursday in Camden, north London, Larch Maxey, a veteran eco-campaigner, said the aim was “to build a community of civil resistance in response to the climate change science”.

“In 2022 you have got tens of thousands of peer-reviewed papers spelling out the climate science,” he said. Authorities such as David Attenborough and David King, the former government chief science officer, were in agreement, he said: there is a narrow window of two to three years in which to act. “We are facing the end of civilisation if we do not act on the climate emergency. We are heading towards societal collapse.

“When your house is on fire, you stop pouring petrol on the flames,” he said. “That’s basically the demand - no new licences. We are in a crisis. Let’s stop digging out new oil and gas.”

New kids on the blockade

Just Stop Oil doesn't just share rhetoric with [Extinction Rebellion](#), it sits within an arc of escalation that began with that group's blockades of five Thames bridges in 2018. Since then, the environmental movement has continued to explore new non-violent tactical provocations to draw attention to its demands.

Many of those involved are, like Maxey, veterans of XR and the HS2 protests; McKechnie is one of a number who took action with Insulate Britain. As with those groups, the silhouette of Roger Hallam also looms behind Just Stop Oil. Although the Guardian has been told it is wrong to describe Hallam as the mastermind of this latest campaign, he featured prominently in early coverage of its activities.

The key shift in Just Stop Oil is what its supporters say is a move from civil disobedience and into civil resistance. What that means, as Jess Causby, 25, a supporter of the campaign, told the Guardian last month, "is stopping pointing out what the government should or shouldn't be doing [and instead] actively stopping government doing what they shouldn't be."

The question is whether they can pull it off. The record of actions attended by Guardian reporters has not immediately seemed propitious. Young activists who tried to [storm the red carpet at the Baftas](#) two weeks ago misjudged how difficult it would be to reach, and ended up blocking its road-entrance instead. Kai and Maddie were intercepted before they could prove a nuisance at Arsenal. A small group who tried to disrupt play at Tottenham were also swiftly handled.

Their next plan is to tackle a much bigger target, and they can expect to be anticipated. Oil companies have already begun to [make preparations](#). What will happen next remains to be seen.

Not a single arrest made during Extinction Rebellion's four-day 'The Big One' protest

No protesters were arrested across the whole of Extinction Rebellion's four-day 'The Big One' action in central London this weekend, in a reflection of the group's decision to 'quit' disruptive action.

In a weekend which included the London Marathon passing through several parts of the city occupied by Extinction Rebellion, the climate activists focused on "attendance over arrest and relationships over roadblocks", hoping to attract new faces to their movement.

Extinction Rebellion estimates over 60,000 people turned out for the protests, which were the first mass mobilisation by the group since the Police, Crime Sentencing and Courts Act came into force in June 2022, giving the police wider powers to crack down on disruptive protests.

"The Big One was always designed as an event which prioritised attendance over arrest so that we could build alliances with other organisations, knowing that we are united by the multiple crises we face and that we are stronger together," a spokesperson for Extinction Rebellion told The Big Issue.

"The 200 organisations that supported The Big One were operating collectively for the whole weekend under a Unity Agreement which explicitly ruled out any escalation. Thankfully to everyone involved, everyone abided by this agreement, policing never became genuinely hostile and no arrests were made."
