## (CORRECTED) JUDGMENT

On it appearing to the Tribunal that:

- a. The claim concerns an alleged breach of the duty of collective consultation under section 188 Trade Union & Labour Relations (Consolidation) Act 1992 (**the Act**).
- b. The asset purchase agreement purportedly transferring the employment of the claimants from the first respondent to the third respondent (**the Transfer**) was declared void by court order on 18 November 2022, and accordingly the claimants remained employees of the first respondent.
- c. The second respondent company was established to effect the Transfer by stages but there is no record of its existence at Companies House.

- d. The fourth respondent was not at any time the employer of the claimants and so cannot be liable for the payment of a protective award.
- e. The first respondent has not submitted any response to the claim.

IT IS DECLARED THAT the complaints by each claimant against the first respondent for failure to comply with the requirements of section 188 of the Act with regard to the election of employee respresentatives are well-founded.

IT IS ORDERED THAT:

- 1. The claims against the second, third and fourth respondents are dismissed.
- 2. Judgment is given for each of the claimants against the first respondent.
- 3. Each claimant is entitled to a protective award for the maximum period of 90 days, with the protective period commencing on 18 November 2022.
- 4. A full list of the claimants is annexed to this Judgment.
- 5. These proceedings are stayed for the period of three months pending an application to the Redundancy Payments Service in respect of the protective awards.
