In response to your first question, I can confirm that Vaxzevria (COVID-19 vaccine AstraZeneca) remains authorised in the UK. I would like to highlight the body responsible for advising the UK Government on the COVID-19 vaccine roll out is the Joint Committee on Vaccination and Immunisation (JCVI), so you may wish to contact them for information on when Vaxzevria was no longer used in the UK vaccination programme.

The MHRA does not hold the information requested in your second question. You may wish to contact the UK Health Security Agency.
