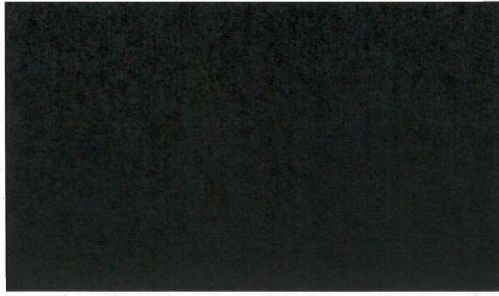

Release of Information

Thank you for your correspondence of 15 January 2020 in which you requested the following information:

'A project requires some data, which I hope you can supply per the Freedom of Information Act. Please provide the means, samples sizes, and standard deviations for the subtests of the Naval Service Recruiting Test (NSRT) by narrow ethnic group for the last 5 years. Ethnicity should be as narrow as possible, e.g. Bangladeshi rather than Asian if that applies to your recording. If it is more convenient, please generate this data in a raw format for each individual with ethnicity in one column and subtest results in the other columns. This may be simpler and circumvent restrictions on generating new information.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information (FOI) Act 2000.

A search for the information has now been completed within the Ministry of Defence and I can confirm that information in scope of your request is held which can be found detailed within the attached Annex to this letter.

Notes

1. Analysis produced on recruitment tests undertaken between 1 April 2014 and 31 March 2019.
2. 'Any Other White Background' is comprised of applicants who declared an ethnicity of 'Any Other White Background', 'White English/Welsh/Scottish/Norther Irish/British' and 'White Gypsy or Irish Traveller'. Due to changes in how ethnicity was recorded with the introduction of the Defence Recruiting System (DRS), 'Any Other White Background' and 'White English/Welsh/Scottish/Norther Irish/British' have been grouped. Applicants with the ethnicity 'White Gypsy or Irish Traveller' are also included in this grouping due to a small sample size.
3. Sample size has been rounded to the nearest 10 in line with disclosure control policy. Figures ending in 5 are rounded to the nearest 20 to avoid bias.
4. Mean and Standard Deviation have been rounded to one decimal place. The recruitment test is scored using whole numbers.
5. Records that have a total score of zero are excluded from the analysis as the majority of these are considered to represent applicants who failed to attend. Where a score is higher than the maximum possible score for that section this is assumed to have been recorded in error, therefore these scores and the total scores for these records have been excluded.
6. Some records contain missing information for particular elements of the test. Therefore, the sample size may vary between test elements.
