JUDGMENT

Any monetary complaints which were advanced are struck out. The complaints for a protective award are unaffected by this decision.

REASONS

1. By a letter dated 17th January 2023 the Tribunal gave the Claimants who have monetary claims an opportunity to make representations or to request a hearing, as to why any monetary parts of the claim should not be struck out because they have not been actively pursued.
2. The Claimants have failed to make representations in writing why this should not be done or to request a hearing. Therefore, all monetary complaints other than that for a protective award are struck out.
