Authorized Amendment

The Regulated Community is reminded to check this amendment against any applicable AAMC, Waivers or Exemptions to ensure their ongoing validity.

On completion of the Flying Display Season, the MAA Flying Display Team (FDT) review RA 2335 to ensure it remains fit for purpose. Although no Request for Change were submitted by the Regulated Community, the FDT look at lessons identified during the DS in order to adapt the RA to meet future requirements. Additionally, RA 2335 takes account of changes that will be made to CAA CAP 403 - Flying Displays and Special Events as it is essential the two documents remain aligned. Issue 12 of RA 2335 changes include an updated definition of Air Display to include specific timings of an event, updated timings for validations, clarification over the number of passes that can be conducted during military Flypasts, updated AAMC for congested areas, updated detail on FDD revalidations and upgrades, adjusted AAMC associated with the protection of third parties, clarification on safety critical messages passed over the air to ground radios and inclusion of new Guidance Material for the use of RPAS at Flying Displays.
