# AMENDED JUDGMENT

**UPON** hearing evidence from the claimants and the claimants submitting schedules of loss following the hearing

The Judgment of the Tribunal is:

- 1. <u>The correct identity of the claimants' employer is Emagination Holdings Ltd (In</u> <u>Creditors Voluntary Liquidation); the claimants are permitted to amend the</u> <u>claim to substitute that company as the respondent, where necessary.</u>
- 2. The claims of all claimants that the First Respondent failed to consult in relation to the intended redundancies contrary to s.188 TULR(C)A 1992 are well founded and succeed.
- 3. It is just and equitable to make a protective award in respect of each of the claimants for 90 days' pay.
- 4. <u>The dates of employment (and the commencement of the protected period) for</u> <u>each claimant are listed in Appendix 1 (attached)</u>
