**PROTOCOL BETWEEN THE GOVERNMENT OF THE UNITED
KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE
GOVERNMENT OF UKRAINE ON AMENDMENTS TO THE
AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED
KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE
GOVERNMENT OF UKRAINE ON INTERNATIONAL ROAD
TRANSPORT**

The Government of the United Kingdom of Great Britain and Northern Ireland, on the one hand, and the Government of Ukraine, on the other hand ("the Contracting Parties"),

Desiring to further develop bilateral relations with the aim of facilitating international road transport between the two countries as well as transit through their territory, have agreed to make such amendments to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Ukraine on international road transport signed on December 13, 1995 in London (hereinafter - the Agreement);

ARTICLE 1

In paragraph 5 of Article 2 «Definitions» in the Agreement the words «Ministry of Transport of Ukraine» are replaced with the words «Ministry of Infrastructure of Ukraine. ».

ARTICLE 2

Paragraph 1 (c) of Article 5 «Carriage of Goods» of the Agreement shall be replaced by the following text:

"Between any point in the territory of the country of the other Contracting Party and any point on the territory of a third country".

ARTICLE 3

After sub paragraph (h) add subparagraph (i) to paragraph 1 of Article 6 «Exemption from Permits» using the following text:

"(i) the carriage of goods by Euro-5 and above category vehicles registered in the territory of country of one of the Contracting Parties, in the territories of the countries of the other Contracting Parties."

ARTICLE 4

1. This Protocol is an integral part of the Agreement and is concluded for the period of validity of this Agreement. This Protocol shall enter into force on the date of receipt of the last notification by which the Parties notify each other in writing that their respective internal procedures for entry into force of this agreement have been fulfilled.

2. Differences between the Contracting Parties concerning the interpretation and/or application of this Protocol shall be settled by the Joint Committee established in accordance with Article 13 of the Agreement.
