Thank you for your correspondence of 2 March 2021 in which you requested the following information:

I would be most grateful if you would provide me, under the Freedom of Information Act, details in respect to the contract below.

The details we require are:

- Suppliers who applied for inclusion on each framework/contract and were successful & not successful at the PQQ & ITT stages
- Actual spend on this contract/framework (and any sub lots), from the start of the contract to the current date
- Start date & duration of framework
- Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?

- Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?
- Who is the senior officer (outside of procurement) responsible for this contract?

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held.

In response to part one of your request, I can advise you that there was no PQQ or ITT stage for this particular contract as it was a single source award to I-Coach Academy Limited.

In response to part two of your request, from 1 December 2020 to 5 March 2021, the amount spent is £2,980,00.

In response to parts three, four and five of your request, as this is a single contract, no framework exists. The contract duration is from 1 December 2020 to 31 March 2021 of which there is no extension included however, a separate contract for similar requirements may be required in the future.

In response to part six of your request, there are a number of senior officers who have been involved in this contract. As such, it is not possible to apportion responsibility (outside of procurement) to one individual senior officer.
