## Advice and Assistance

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. To comply with this duty, we are able to confirm that we do not allocate funding grants on a fiscal or calendar year basis. Instead, we provide funding at 'programme' level, which takes place over a number of years. The current programme ('Affordable Homes Programme') has been allocated funding for the period 2021-2026. Providing information for 2023 alone would require us to create information.
