Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

Under Freedom of Information provisions please provide a copy of all records of exchanges (letters, emails, records of meetings or telephone calls) with Isle of Wight MP, Bob Seely, relating to the decision by Homes England to transfer the Venture Quays site to the Isle of Wight Council. We do not require sight of any correspondence raised by him on behalf of Isle of Wight constituents.

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Development team and our Contingent Asset and Liabilities team who would have the requested information if held.
