(2) For the purposes of subsection (1)—

(a) information may be reasonably accessible to the applicant even though it is accessible only on payment, and

(b) information is to be taken to be reasonably accessible to the applicant if it is information which the public authority or any other person is obliged by or under any enactment to communicate (otherwise than by making the information available for inspection) to members of the public on request, whether free of charge or on payment.

(3) For the purposes of subsection (1), information which is held by a public authority and does not fall within subsection (2)(b) is not to be regarded as reasonably accessible to the applicant merely because the information is available from the public authority itself on request, unless the information is made available in accordance with the authority's publication scheme and any payment required is specified in, or determined in accordance with, the scheme.

## Advice and Assistance

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. We can advise that the link below shows the Affordable Homes Programme 2021 to 2026 allocations. The document titled 'Schemes confirmed by Homes England' contains the list of schemes that have reached grant confirmation stage as at the end of March 2023. Column A (Region Name) in the spreadsheet can be filtered to the South West region and you are able filter further down by Lead Organisation (column D) to find the schemes that Live West received grant confirmation for.
