## Converter Academy Order

### Project: To discuss the application for Kings International College to join Bourne Education Trust, Surrey

#### AB discussion:

- AB members discussed the governance structure of Bourne Education Trust.
- It was noted there was no primary expertise on the trust board, however the trust has indicated they will be appointing someone to the board with this educational expertise.
- The RD was concerned that no consultation had taken place and so would like this to be completed before confirming final approval.
- RD was happy to approve in principle subject to the consultation.

#### RD decision: Approve with conditions:

- Consultation to take place and results to be brought to RD for review before final approval of conversion.

**Further actions required:** Inform the school, trust and local authority of the RD decision.

## Converter Academy Order

### Project: To discuss the application for St Pauls CofE (Aided) Primary School to join The Good Shepherd Trust, Surrey.

#### AB discussion:

- AB members discussed the falling roll of the school and whether this would cause a problem for the trust. It was noted that the local authority will be looking to reduce the capacity of the school in due course.
- AB members discussed the trust's capacity for school improvement, highlighting that the school Improvement plan could be stronger, however did feel that the school would be a capacity giver to the trust.
- AB members discussed potential timeframes of this school and the other pipeline schools joining the trust.
- The RD decided that more information was needed from the trust on the school improvement offer across its existing academies, specifically the actions that the trust has been taking and the impact of these, as well as information on who the people are doing the work, and their experience.

**RD decision:** Defer.

## **Converter Academy Order**

**Project: To discuss the application for Holy Family Catholic Primary School to join St Thomas Catholic Academies Trust, Slough.**

- AB members discussed the local context in Slough and the educational needs in the area.

## **Discussion – Not For Decision**

**Project: To discuss the application by Bracknell Forest LA to revoke the dAO for College Hall PRU.**

**AB discussion:**

- AB members discussed the request from College Hall's Management Committee to revoke the academy order due to the financial viability of the PRU.
- The AB members noted that the LA will need to carry out a formal consultation on the closure of the PRU before a final decision can be made on the academy order being revoked.

## **Trust Change**

**Project: To discuss the application for Ousedale School (SAT) Milton Keynes to transfer to E-ACT.**

**AB discussion:**

- AB members discussed E-ACT's capacity due to the trust having 9 other schools in the pipeline. It was confirmed to the AB that the trust is looking at adapting their central systems to aid the transfers.

- AB members were cautious of the transfer as this would be the trust's first school in Milton Keynes, however the members reflected it would be positive to develop in the area and the school would be a capacity giver.
- The performance results of the schools currently in EACT were discussed in the context of how this would benefit Ousedale School.
- AB members discussed E-ACT's governance structure.

**RD decision:** Approve.

**Conflicts:** Sarah Bennett. Personal connection to Ousedale school since 2018 to present. Papers issued, excluded this item and Sarah left the room during the discussion.
