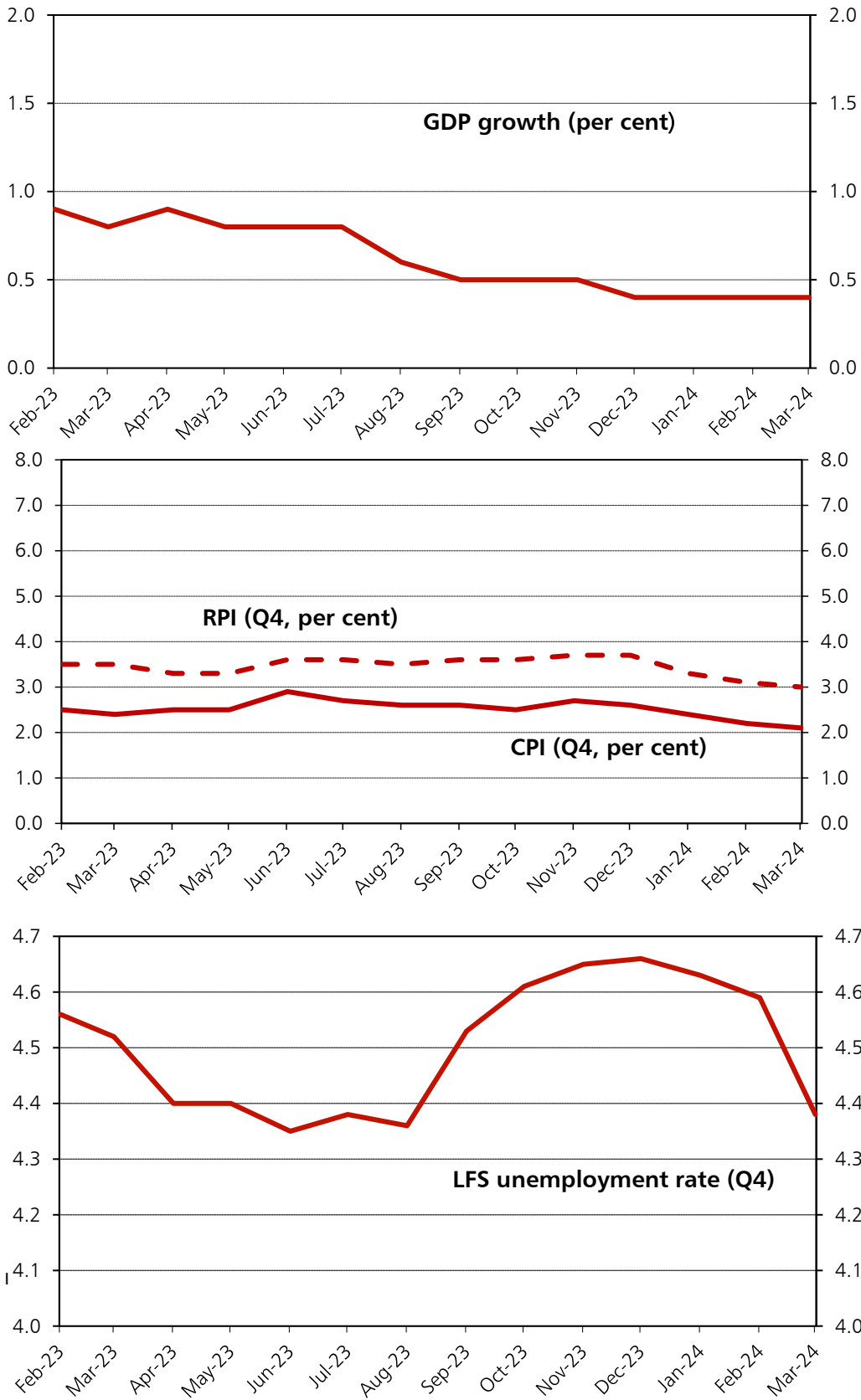

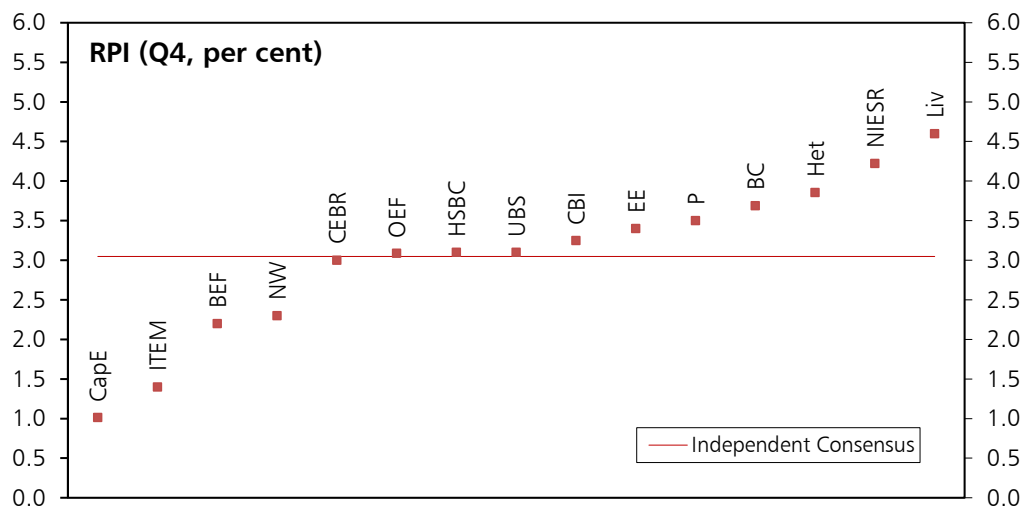
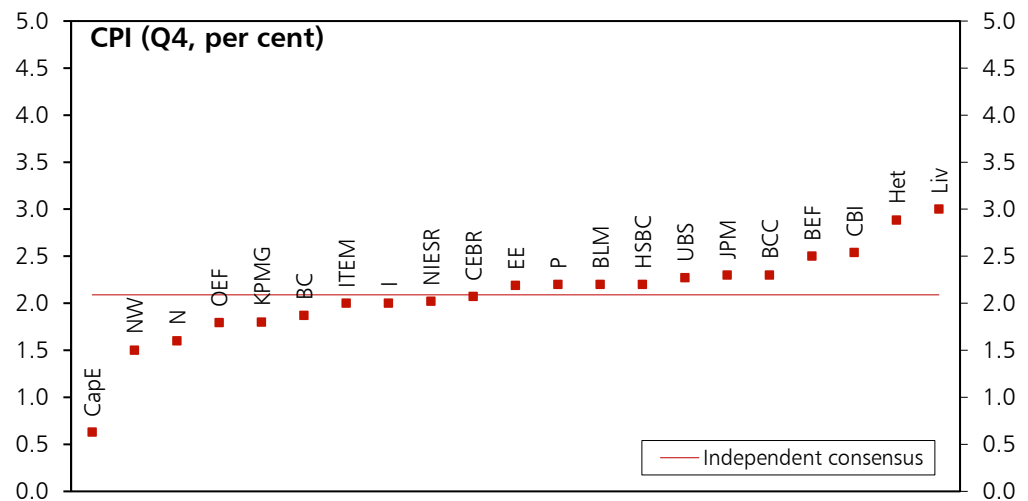
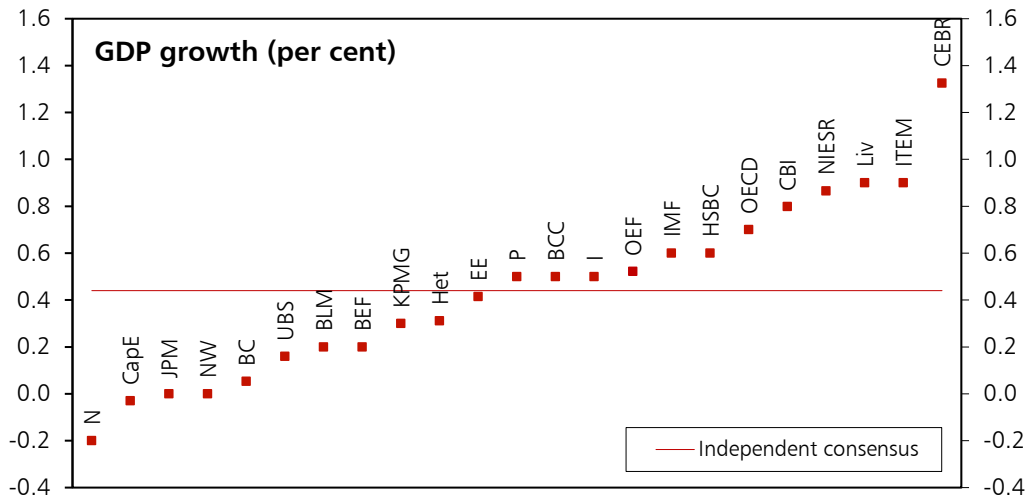
## Average of independent forecasts for 2024; GDP growth, CPI and RPI inflation and unemployment



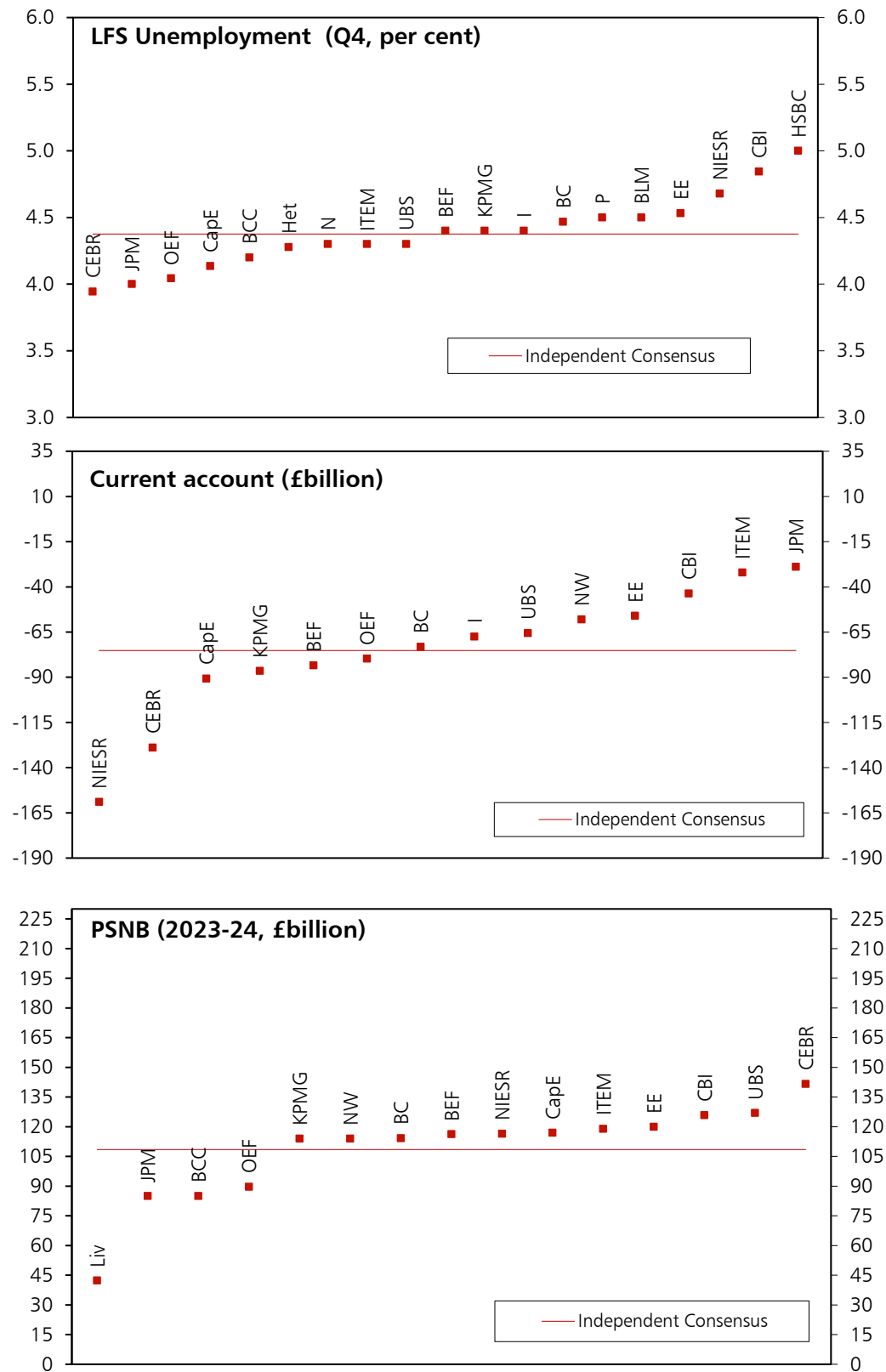
## Average of independent forecasts for 2024; Current account and PSNB (2023-24 & 2024-25)



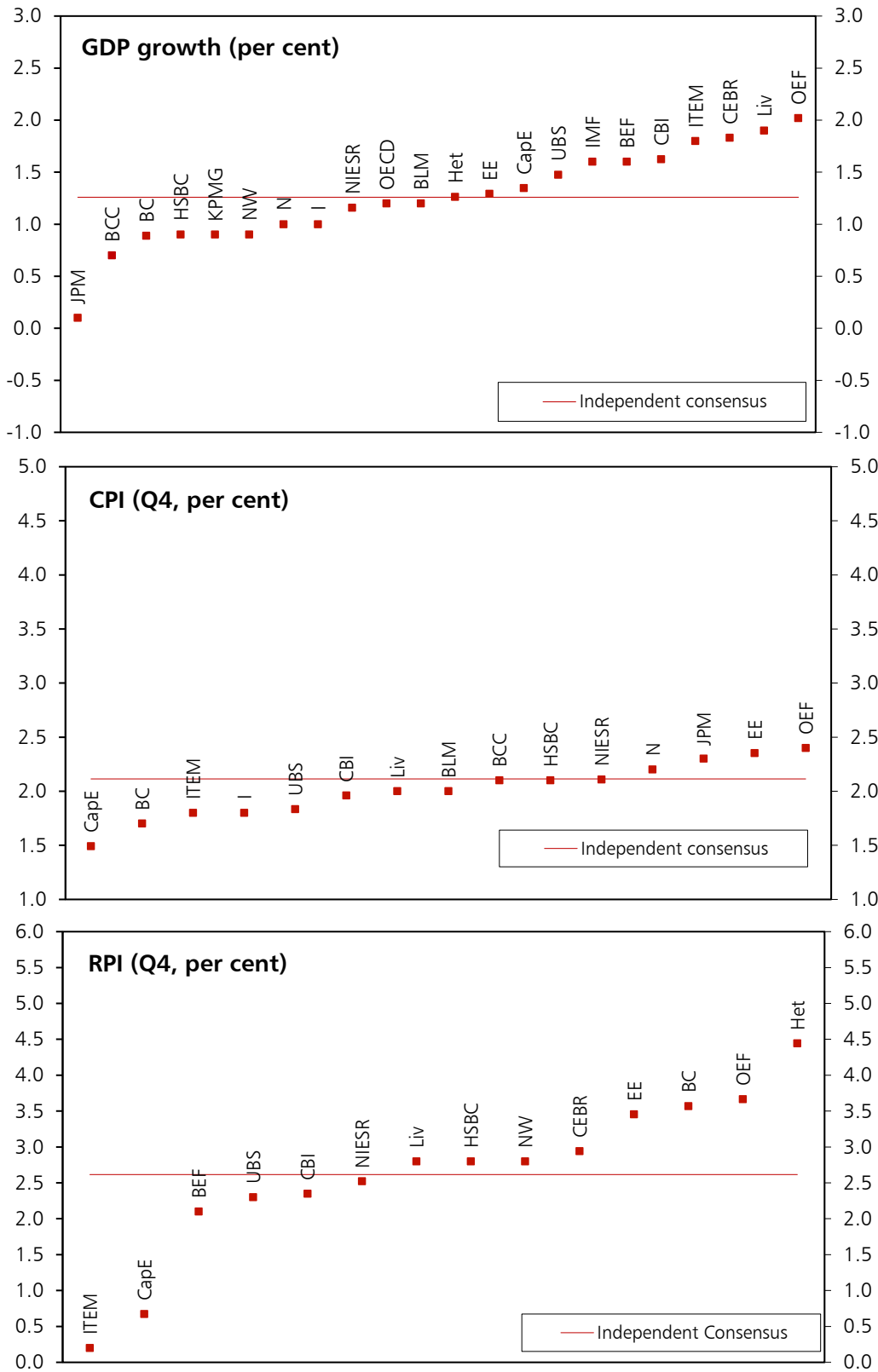
## Dispersion around the independent consensus for 2024; GDP growth, CPI and RPI inflation made in the last 3 months



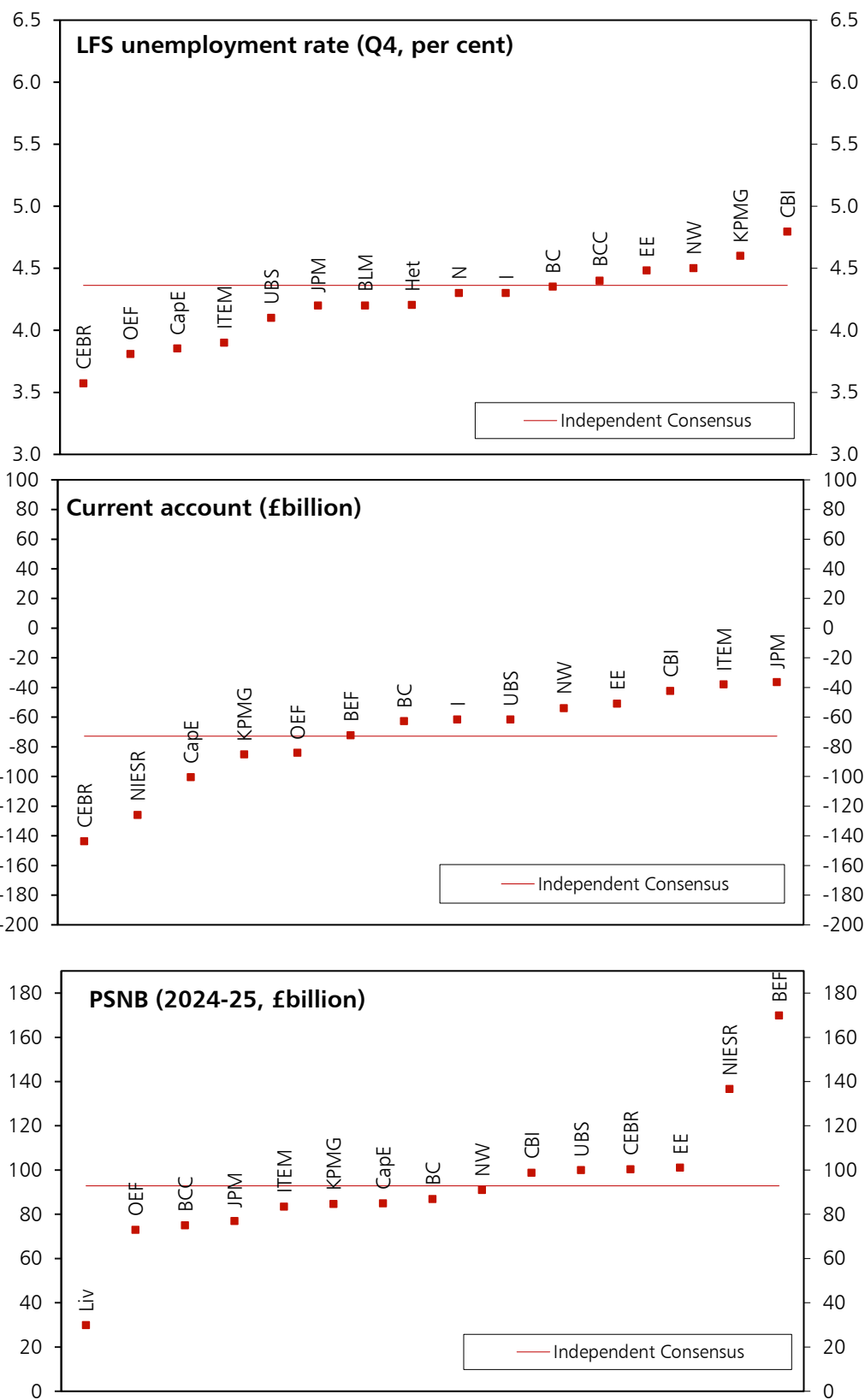
**Dispersion around the independent consensus for 2024; LFS unemployment, current account and PSNB (2023-24) made in last 3 months**
