### REQUEST FOR INFORMATION: Calf exports

Thank you for your request for information of 10th August about Calf exports. APHA have handled your request under the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

"Calf exports from Northern Ireland

What numbers of live calf exports from Northern Ireland to Irish Republic have been recorded in each of the past 5 years?"

APHA do not hold information for Northern Ireland this can be accessed via DAERA here: https://www.daera-ni.gov.uk/

"What numbers, if any, of live calf exports from mainland UK to Northern Ireland have been recorded in each of the past 5 years?"

Please see table for the total number of Export Health Certificates (EHC) issued for live cattle from GB to Northern Ireland between 01/01/2020 – 31/07/2023.

Please note that the data provided relates to cattle. The animals age is not recorded, therefore we cannot ascertain if these exports included any calves.

"What veterinary assessments are undertaken on fitness to travel of calves pre-journey to Irish Republic, and what proportion have failed that assessment and on what basis in each of the past 5 years?"

The certifying vet should inspect the calves and confirm fitness to travel.

In addition to the assessment carried out by an OV, for the transport of un-weaned calves, supervised loadings are undertaken prior to the animals leaving GB. Inspectors from APHA perform various checks during supervised loadings to ensure the welfare of animals should be maintained throughout the journey. During the supervised loadings, APHA inspectors will, amongst other things, ensure all animals are fit to be transported. If an animal is deemed unfit to travel by the inspectors, it will be removed from the loading process.

"What legal advice, if any, has been sought or provided as to whether welfare provisions of calves being exported from Irish Republic are compliant with EU legislation?"

The export of calves from Republic of Ireland is the responsibility of Department of Agriculture, Food and the Marine (DAFM). APHA do not hold any information on this.

The information that we have provided is a true reflection of the information that we have access to. We cannot guarantee the accuracy of this data, as we can only rely on the information that has been input into external customer facing systems by third parties.
